

FIELD NOTES

7.043 Acre Tract

All that certain tract or parcel of land lying and being situated in Grimes County, Texas, out of the William Burney Survey, Abstract No. 10 and also being a part of First Tract, called 15 acres, more or less, and a part of Second Tract, called 3.8 acres, more or less, both tracts described in a Deed from Fred Maniha, et ux, to Martin Ed Kapchinski, et ux, dated July 11, 1972, of record in Volume 307, Page 205 of the Deed Records of Grimes County, Texas and more fully described by metes and bounds as follows:

BEGINNING at a found 3/8 inch iron rod, near fence corner in a branch, for the Southeast corner of called Second Tract mentioned above, same being an interior corner of a called 17.278 acre tract of land owned by Charles G. Whiteside of record in Volume 591, Page 391 of the Deed Records of Grimes County, Texas and said rod being the most Easterly corner of the tract of land herein described;

THENCE S 69 deg. 00 min. 00 sec. W, 397.27 ft., generally along a fenced South line of called Second Tract mentioned above and a North line of called 17.278 acre Whiteside tract of record in Volume 591, Page 391 of the Deed Records of Grimes County, Texas to a found 3/8 inch iron rod, at fence corner, for its most Westerly Northwest corner;

THENCE S 21 deg. 00 min. 58 sec. E, along a fenced West line of called 17.278 acre Whiteside tract of record in Volume 591, Page 391 of the Deed Records of Grimes County, Texas, **PASSING** at 353.59 ft. a found 3/8 inch iron rod, at fence corner, for its Southwest corner and **CONTINUING** A **TOTAL DISTANCE OF** 393.01 ft. to a set ½ inch iron rod, at fence corner, for the most Southerly Southeast corner of the tract of land herein described and same being in the apparent North line of a called 20.263 acre tract of land owned by Ray and Mary Jones of record in Volume 928, Page 362 of the Real Property Records of Grimes County, Texas;

THENCE S 69 deg. 06 min. 14 sec. W, 627.77 ft., along the South line of called 15 acre, more or less, tract mentioned above and an apparent North line of called 20.263 acre Jones tract of record in Volume 928, Page 362 of the Real Property Records of Grimes County, Texas to a set ½ inch iron rod for the Southwest corner of the tract of land herein described:

THENCE N 37 deg. 59 min. 06 sec. W, 271.82 ft., along a West line of the tract of land herein described to a set ½ inch iron rod, at a cyclone fence corner, for its most Westerly Northwest corner:

THENCE N 87 deg. 34 min. 00 sec. E, 50.93 ft., along a North line of the tract of land herein described to a found ½ inch iron rod, in a field, for the Southwest corner of a called 2.00 acre tract of land owned by Stephen and Cecilia Gurka of record in Volume 546, Page 682 of the Deed Records of Grimes County, Texas;

THENCE N 57 deg. 11 min. 30 sec. E, 329.82 ft., along a South line of called 2.00 acre Gurka tract of record in Volume 546, Page 682 of the Deed Records of Grimes County, Texas to a found ½ inch iron rod, in a field, for its Southeast corner;
