CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the EAST FORK, MIDDLE FORK AND WEST FORK OF COTTONWOOD CREEK, MILL CREEK AND AN UNNAMED CREEK, tributaries of the KLAMATH RIVER for IRRIGATION of 294.4 ACRES.

This right was perfected under Permit S-44755. The date of priority is JULY 25, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 7.37 CUBIC FEET PER SECOND (CFS); BEING 0.56 CFS FROM THE EAST FORK OF COTTONWOOD CREEK, 0.48 CFS FROM THE MIDDLE FORK COTTONWOOD CREEK, 1.66 CFS FROM WEST FORK COTTONWOOD CREEK, 4.15 CFS FROM MILL CREEK AND 0.52 CFS FROM THE UNNAMED CREEK, or its equivalent in case of rotation, measured at the points of diversion.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

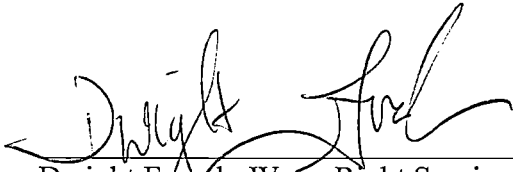

This certificate is issued to correct a scrivener's error in the description of the recognized survey corner for Diversion No. 5, which described that portion of the water right previously confirmed by water right Certificate 56488, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DEC 19 2017, approving Transfer Application T-12715. This certificate supersedes Certificate 93409.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
