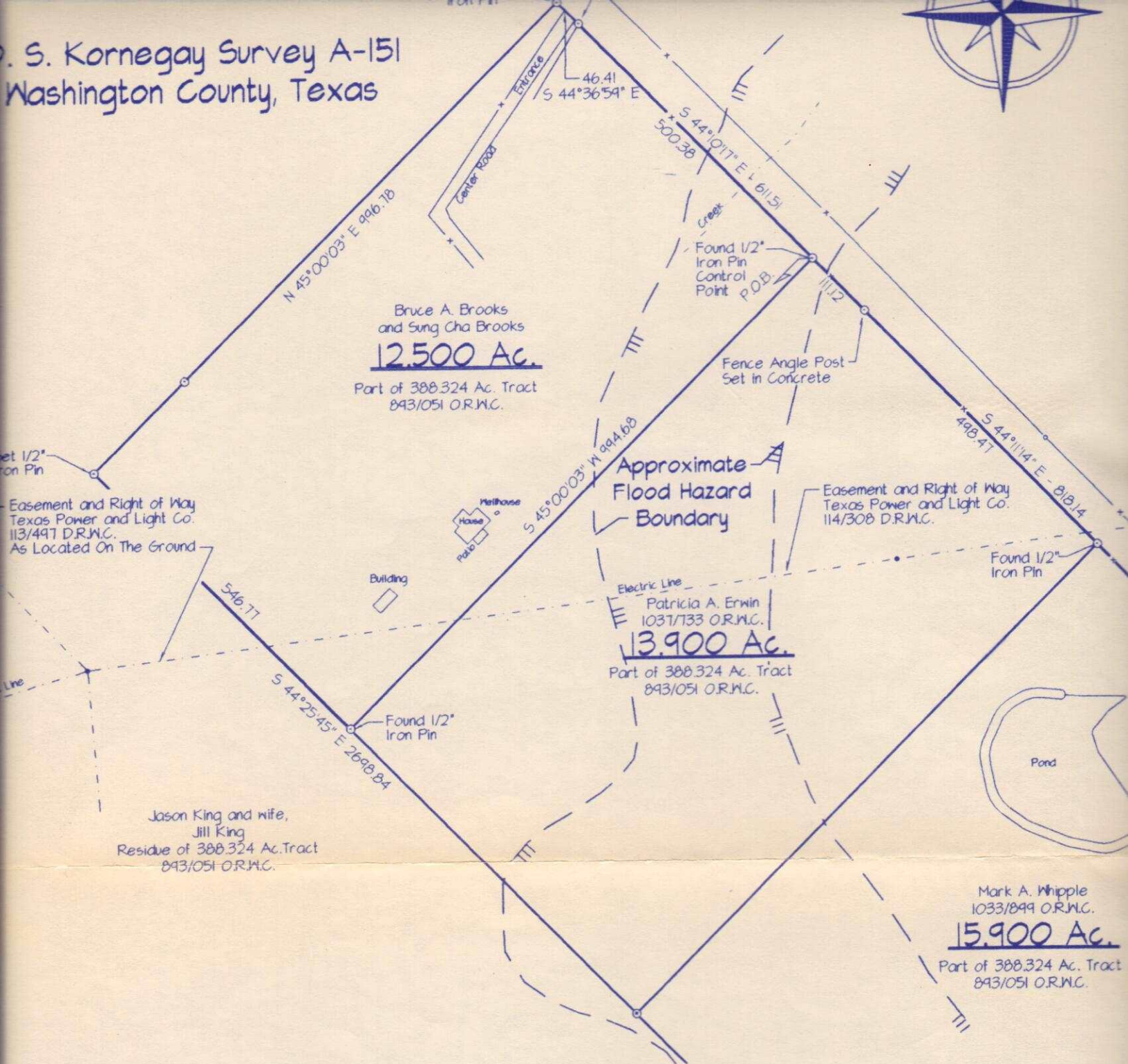

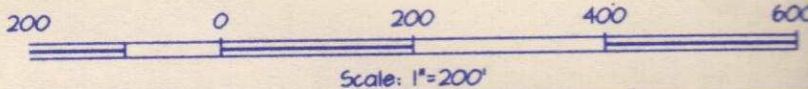

No single-family residential dwellings shall be constructed upon the property which shall contain less than 1,800 square feet of covered living area, exclusive of open porches, patios, garages and other buildings. Conventional building materials, methods and traditional architectural styles are to be utilized in all residential construction.

No mobile homes, trailer homes, modular homes, manufactured homes or the like shall be permitted on any tracts at any time. No structure of a temporary character shall be permitted upon any tract or part thereof, including the foregoing and railroad cars of any type, automobiles, boxcars, cabooses, buses and the like.

No building or permanent structure of any nature, other than fencing will be constructed within 50 feet of all property lines.

No more than one head of livestock per acre or cow-calf unit per acre shall be kept and/or placed on any tract. No swine or poultry brood operations shall be kept or permitted on any tract, provided, that children of residents occupying this acreage shall be allowed to participate in FFA projects. A mare with an unweaned colt shall be considered one unit. There shall be no commercial operation for raising any type of livestock allowed on this acreage.

No outdoor toilets or privies shall be erected on any tract, but only approved-type septic tanks and water wells shall be used. All septic tanks shall be constructed and maintained in accordance with the standards specified by the State Department of Health and/or any other government agency whose rules and regulations govern installation and use of sewage disposal systems.

No tract or any part thereof shall be used as a junk yard, wrecking yard, derelict car, truck or vehicle lot, or trailer park. No abandoned or junk cars, tractors or other vehicles are permitted on any tract or any part thereof.

No tract may be divided into more than one additional parcel that shall contain not less than forty (40%) percent or more than sixty (60%) percent of the entire tract.



Information About Brokerage Services

TYPES OF REAL ESTATE LICENSE HOLDERS:

A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:

AS AGENT FOR OWNER (SELLER/LANDLORD): The broker becomes the property owner's agent through an agreement with the owner, usually in a written listing to sell or property management agreement. An owner's agent must perform the broker's minimum duties above and must inform the owner of any material information about the property or transaction known by the agent, including information disclosed to the agent or subagent by the buyer or buyer's agent.

AS AGENT FOR BUYER/TENANT: The broker becomes the buyer/tenant's agent by agreeing to represent the buyer, usually through a written representation agreement. A buyer's agent must perform the broker's minimum duties above and must inform the buyer of any material information about the property or transaction known by the agent, including information disclosed to the agent by the seller or seller's agent.

AS AGENT FOR BOTH - INTERMEDIARY: To act as an intermediary between the parties the broker must first obtain the written agreement of each party to the transaction. The written agreement must state who will pay the broker and, in conspicuous bold or underlined print, set forth the broker's obligations as an intermediary. A broker who acts as an intermediary:

- Must treat all parties to the transaction impartially and fairly;
- May, with the parties' written consent, appoint a different license holder associated with the broker to each party (owner and buyer) to communicate with, provide opinions and advice to, and carry out the instructions of each party to the transaction.
- Must not, unless specifically authorized in writing to do so by the party, disclose:
 - that the owner will accept a price less than the written asking price;
 - that the buyer/tenant will pay a price greater than the price submitted in a written offer; and
 - any coincidental information or any other information that a party specifically instructs the broker in writing not to disclose, unless required to do so by law.

AS SUBAGENT: A license holder acts as a subagent when aiding a buyer in a transaction without an agreement to represent the buyer. A subagent can assist the buyer but does not represent the buyer and must place the interests of the owner first.

TO AVOID DISPUTES, ALL AGREEMENTS BETWEEN YOU AND A BROKER SHOULD BE IN WRITING AND CLEARLY ESTABLISH:

- The broker's duties and responsibilities to you, and your obligations under the representation agreement.
- Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated.
