Finally, I am aware that under Section 32.46 of the Texas Penal Code, a person commits an offense if, with intent to defraud or harm any person, he, by deception, causes another to sign or execute any document affecting property or service or the pecuniary interest of any person, and that an offense under such Section is (i) a felony of the third degree if the value of the property, service, or pecuniary interest is \$20,000.00 or more, but less than \$100,000.00, which is punishable by a fine of \$10,000.00 and confinement in the Texas Department of Corrections for a term of not more than 10 years or less than 2 years; (ii) a felony of second degree if the value of the property, service, or pecuniary interest is \$100,000.00 or more, but less than \$200,000.00, which is punishable by a fine of \$10,000.00 and confinement in the Texas Department of Corrections for a term of not more that 20 years or less than 2 years, or; (iii) a felony of the first degree if the value of the property, service, or pecuniary interest is in excess of \$200,000.00, which is punishable by a fine of not to exceed \$10,000.00 and confinement in the Texas Department of Corrections for a term of not more than 99 years or less than 5 years.




