


EXHIBIT "A"



Field Notes

Situated within the Corporate Limits of the City of Paris, Lamar County, Texas, a part of the Joseph Leach Survey, Abstract 524, also being a part of a tract of land conveyed to Ruth Miller by deed recorded as Lamar County Document No. 074170-2009, and being further described as follows:

Beginning at an iron pin set in the East Boundary Line of Boardwalk Street at the most Southerly Southwest corner of said Miller tract and at the Northwest corner of Lot L of Paris Business Park Phase 2 as shown by plat recorded in Envelope 386-D of the Lamar County Plat Records;

Thence North 01° 24' 29" East with said East Boundary Line (bearing per Lamar County Doc. No. 074170-2009) a distance of 217.16 feet to an iron pin set at an inside corner of the Miller tract;

Thence North 88° 35' 31" West a distance of 25.00 feet to an iron pin set for corner; Thence North 01° 24' 29" East a distance of 43.30 feet to an iron pin set for corner;

Thence North 73° 26' 37" East a distance of 220.75 feet to a post found at an inside corner of the Miller tract and at the Southwest corner of a tract of land conveyed to Hugh Taylor by deed recorded in Volume 331, Page 007, of the Lamar County Real Property Records:

Thence South 87° 08' 54" East with the South Line of said Taylor tract a distance of 60.03 feet to an iron pin found at the most Easterly Northeast corner of the Miller tract and at the Northwest corner of Lot 11 of Paris Business Park as shown by plat recorded in Envelope 351-A of the Lamar County Plat Records;

Thence South 01° 24' 29" West with the East Line of the Miller tract and with the West Lines of Lots 11, 10, and 9 of said Paris Business Park a distance of 326.00 feet to an iron pin set at the Southeast corner of the Miller tract and at the Northeast corner of the above-referenced Lot L;

Thence North 88° 50' 07" West with the South Line of the Miller tract and with the North Line of Lot L a distance of 245.00 feet to the place of beginning, and containing 1.744 acre of land.
