

DESCRIPTION OF SURVEY

All that parcel of land situated in the Town of Capon Bridge, Bloomery District, Hampshire County, West Virginia at the north-west intersection of West Virginia Secondary Route 15 and Maple Street and approximately 1/4 mile northeast of the intersection of West Virginia Secondary Route 15 with U.S. Route 50 and is more particularly described as follows:

Beginning at (3), an 1/2 inch capped (Davy) rebar, found, in or near a fence line, a common corner to Lot Nos. 9 and 14 of Mauzy Addition now owned by Lake M. Henderson, widow (see Will Book 32, Page 774 and Deed Book 112, Page 351) of which this parcel is a part and being a common corner to Lot No. 13 of Mauzy Addition now owned by Roger G. & Sylvia J. Bourne (see Deed Book 347, Page 312) and to Lot No. 10 of Mauzy Addition now owned by Naomi Strother, widow (see Deed Book 211, Page 243). Said iron rod is referenced by (B), an 1/2 inch capped (Davy) rebar, found, which bears N 33-27'-38" E at 100.00 feet and by (2), a fence post at a fence corner, found, which bears N 56-33'-37" W at 150.00 feet; thence, with Lot No. 9 and with a line of Strother and along or near a fence line, for one line,

FIRST COURSE, S 56 Degrees - 33 Minutes - 37 Seconds E, 200.00 feet to

(4), a flush 5/8 inch capped iron rod, set, on the northwest bounds of West Virginia Secondary Route 15 (Coldstream Road), 25 feet from its centerline and from which Potomac Edison Pole No. N6813 bears S 16-22'-20" W at 133.61 feet and from which a 6-inch triangular concrete monument, found, on the southeast side of said county road bears N 43-29'-33" E at 283.72 feet; thence, with the northwest bounds of said county road at 25 feet from centerline and with a line of Lot No. 9 and continuing with the line of Lot. Nos. 8 and 7 of Mauzy Addition now owned by Lake M. Henderson, widow (see Will Book 32, Page 774 and Deed Book 112, Page 351) for one line,

SECOND COURSE, S 33 Degrees - 27 Minutes - 38 Seconds W, 150.00 feet to

(5), a flush 5/8 inch capped iron rod, set, at the northwest intersection of West Virginia Secondary Route 15 and Maple Street (a 50-foot R/W) from which a manhole bears S 81-20'-56" W at 54.26 feet; a water meter bears S 21-34'-26" W at 19.67 feet; Potomac Edison Pole No. M126244 bears S 50-18'-54" W at 45.77 feet; Potomac Edison No. N6813 bears S 86-07'-39" E at 45.15 feet and a 6-inch triangular concrete monument, found, on the southeast side of said county road and on the northeast side of a road which

Henderson, widow (see Will Book 32, Page 774 and Deed Book 112, Page 351) from which (1), a fence post at a fence corner, found, bears N 56-33'-37" W at 150.00 feet; a manhole bears S 83-19'-25" W at 72.31 feet and Potomac Edison Pole No. M126245 bears S 47-45'-57" W at 52.81 feet; thence, leaving Maple Street and with the original line of Lot Nos. 7, 8 and 9 and with a line of Lot Nos. 16, 15 and 14 of Mauzy Addition now owned by Lake M. Henderson, widow (see Will Book 32, Page 774 and Deed Book 112, Page 351) for one line,

FOURTH COURSE, N 33 Degrees - 27 Minutes - 38 Seconds E, 150.00 feet to

TO THE POINT OF BEGINNING, CONTAINING 30,000 SQUARE FEET (0.69 ACRE), MORE OR LESS.

As survey now completed on November 22, 1994, by R & S Services, Inc., Rickie C. Davy, LLS, Capon Bridge, West Virginia, the adjoining Plat No. D94-072, prepared and intended to be used as a part of this description.

Being an inclusive survey of Lot Nos. 7, 8 and 9 of Mauzy Addition of which an one-half undivided interest was devised unto Lake M. Henderson by the Last Will and Testament of Harold Henderson which was probated the 18th day of January, 1978 and recorded in Will Book 32 at Page 774 and being the same lots that were conveyed unto William H. (Harold) Henderson and Lake M. Henderson, his wife from J.W. Shanholtzer and Annie M. Shanholtzer, his wife by deed dated the 24th day of May, 1947 and recorded in Deed Book 112 at Page 351 in the Office of the Clerk of the County of Hampshire County, West Virginia.
