CERTIFICATE OF SURVEY:

I hereby certify only to the parties named hereon that we have surveyed at the direction of said parties, a parcel of land previously described as:

(as provided in Accolade, Inc. Survey No. 94-5704 recorded in Liber 7 of surveys, Pages 538-541, Parcel A)

Beginning on the West line of Section 36, T2N, R2W, Aurelius Township, Ingham County, Michigan at a point 1400.81 feet, N0019'53"W from the Southwest corner of said Section 36; thence continuing N0019'53"W, 330.00 feet; thence N89'58'17"E parallel with the East-West 1/4 line of said Section, 1325.35 feet; thence S0014'27"E along the East line of the West 1/2 of the Southwest 1/4 of said Section, 330.00 feet; thence S89'58'17"W, 1324.82 feet to the point of beginning.

and that we have found or set, as noted hereon, permanent markers to all corners and angle points of the boundary of said parcel and that the more particular legal description of said parcel is as follows:
