## **RIGHT OF WAY**

This Right of Way Agreement made and entered into this day of Alri,

WHEREAS, by Deed dated November 12, 1991 of record in the Hardy County Clerk's Office in Deed Book 215 at Page 687, the Grantor and Party of the First Part received 51 acres, more or less commonly known as "The White Oak Flats", situate in Moorefield District, Hardy County, West Virginia from Cecil Haggerty, et ux.

WHEREAS, by Deed dated January 2, 2012, of record in the Hardy County Clerk's Office in Deed Book 321 at Page 77, the Grantor and Party of the First Part received 39.13 acres, more or less being located and situate along the east side of County route 2/1 and 3.3 miles northwest of U.S. Route 220 and North of Moorefield in Moorefield District, Hardy County, West Virginia from Nim F. High.

WHEREAS, by Deed dated August 31, 1995, of record in the Hardy County Clerk's Office in Deed Book 233 at Page 450, the Grantee and Party of the Second Part received 23 acres more or less, lying and being situate in what is known as the Flats of Moorefield District, Hardy County, West Virginia, from Barbara P. Welton; and

NOW THEREFORE, THIS AGREEMENT WITNESSETH, for and in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid to the Grantor and Party of the First Part does hereby grant, sell and convey unto the Grantees and Parties of the Second Part a general purpose right of way for the life of the Grantees, Charles L. Loving and Geraldine L. Loving. It is understood that gates are in place and shall remain in place or may be moved. The gates are to be open or closed commensurate with livestock presence. It is also understood that the Lovings have another right of access to their real estate and this permissive use is for their lifetime only. The width of the right of way shall remain as is.

TO HAVE AND TO HOLD, the right away herein conveyed unto the Grantees for their lifetime only.
