Wahoo Creek Watershed Plan-Environmental Assessment

Public Meeting

The Lower Platte North Natural Resources District (LPNNRD) is partnering with the Natural Resources Conservation Service (NRCS) to host a Public Meeting for the Wahoo Creek Watershed Plan-Environmental Assessment.




Figure 1. Site Locations

In 1998, the LPNNRD partnered with the NRCS to complete the Wahoo Creek Watershed Plan and Environmental Impact Statement (Plan) under the authority of Watershed Protection and Flood Prevention Act (Public Law 83-566). The Plan identified seventeen floodwater retention structures within the basin to reduce rural and urban flooding, reduce sedimentation and scour, stabilize stream channels, enhance fish and wildlife habitat, enhance water quality, improve economic conditions, and provide recreational opportunities. Seven of the original seventeen structures have been completed. Eleven additional sites are currently being considered for planning, design, and construction due to current Watershed needs (Figure 1).

Federal funding received for flood risk reduction opportunities within the Watershed requires fulfillment of National Environmental Policy Act (NEPA) requirements. A Wahoo Creek Watershed Plan-Environmental Assessment is being completed with a current evaluation of potential flood retention for the eleven floodwater retention structures within the Watershed, and other possible alternatives. Part of this project includes an evaluation of environmental
