CERTIFICATE OF SURVEY:

I hereby certify only to the parties named hereon that we have surveyed and divided into several parcels, at the direction of said parties, a parcel of land previously described as:

Land in the County of Eaton, Township of Eaton, State of Michigan, described as: The East 1/2 of the Southeast 1/4 of the Southeast 1/4, Section 24, T2N, R4W, except that part described as: Commencing on the East Section line at a point 936 feet North of the Southeast corner of said Section 24, thence North on the said East Section line 141 feet, thence West 309 feet; thence South 141 feet; thence East 309 feet to the point of beginning. Also Excepting: That part of the Southeast 1/4 of Section 24, T2N, R4W, Eaton Township, Eaton County, Michigan, described as lying North of an imaginary East-West line drawn at a point 936 feet North of the South 1/4 line of said Section 24.
