Field Notes Description

A 36.77 acres of land out of the JAS. Underwood Survey, Abstract No. 478, Lavaca County, Texas, being the same land described in Deed dated June 20, 1994, from Green Oaks Estate Development Company to Robert G. Powell, and recorded in Volume 46, Page 195, Official Records of Lavaca County, Texas.

Being more fully described by metes and bounds as follows:

BEGINNING: at a 3/8" iron rod found in the north line of Lot 53 of the Green Oak Estates Development,

recorded in Volume 1, Page 19 of the Plat Records of Lavaca County, Texas, being the southwest corner of Lot 18 of said Green Oak Estates Development, same being the

southeast corner of this herein described tract;

THENCE: S 68°22'45" W – 800.00 feet along the north line of said Lot 53 and the south line of this

herein described tract, to a point, from which a 3/8" iron rod found bears N 68°22'45" E – 0.53 feet, being in the east line of Lot 12 of said Green Oak Estates Development, being the northwest corner of said Lot 53, same being the southwest corner of this herein described

tract;

THENCE: N 20°52'15" W - along the east line of said Lot 12 and the west line of this herein described

tract, at 647.26 feet pass a 3/8" iron rod found for the northeast corner of said Lot 12 and the southeast corner of Lot 16 of said Green Oak Estates Development, at 1946.04 feet pass a 5/8" iron rod with cap set in the east line of said Lot 16 and the west line of this herein described tract, in all a distance of 2004.62 feet, to a point, in the centerline of County Road 158, being the northeast corner of said Lot 16, same being the northwest corner of this

herein described tract;

THENCE: N 68°41'45" E – 799.95 feet along the centerline of said County Road 158 and the north

line of this herein described tract, to a point, being the northwest corner of said Lot 18, same

being the northeast corner of this herein described tract;

THENCE: S 20°52'15" E - along the west line of said Lot 18 and the east line of this herein described

tract, at 54.86 feet pass a 3/8" iron rod with cap found in the west line of said Lot 18 and the east line of this herein described tract, in all a distance of 2000.20 feet, to the POINT OF

BEGINNING, containing within these metes and bounds a 36.77 acre tract, more or less.
