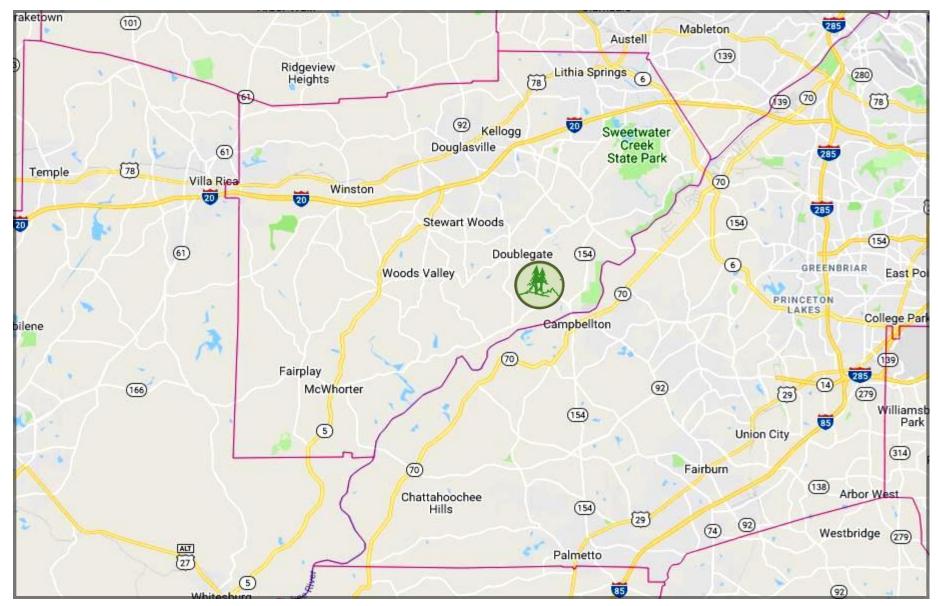






The Location
