

## **Field Notes Description**

61.036 acre tract - Tract 1, of a division survey of a 122.02 acre tract recorded in Volume 475, Page 825, of the Official Records of Lavaca County, also comprised of a portion of the George Miller Survey, Abstract 334, located in Lavaca County, Texas.

Being more fully described by metes and bounds as follows:

**BEGINNING:** at a 5/8" iron rod with cap stamped "RPLS 6368", (Y = 13,641,908.43, X = 2,644,319.05),

set at the south corner of a 61.036 acre tract - Tract 2, (dually surveyed), in the southwest line of said 122.02 acre tract, and in the northeast right of way line of County Road 450, for the

west corner of this herein described tract;

THENCE: N 64°51'12" E -1952.00 feet across said 122.02 acre tract, along the southeast line of said

> Tract 2, and along the northwest line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the east corner of said Tract 2, in the northeast line of said 122.02 acre tract, and in the southwest line of a 1042.00 acre tract conveyed to Ronald Davidson in Volume 151, Page 350 of the Official Records of Lavaca County, Texas, for

the north corner of this herein described tract;

THENCE: S 45°59'29" E -61.41 feet along the southwest line of a said 1042.00 acre tract, the

northeast line of said 122.02 acre tract, and the northeast line of this berein described tract

to a 1/2" iron rod found, for an angle corner of this herein described tract;

S 46°41'53" E -971.18 feet continuing along the southwest line of a said 1042.00 acre THENCE:

tract, the northeast line of said 122.02 acre tract, and the northeast line of this herein described tract to a 1/2" iron rod found at the north corner of a 57.69 acre tract conveyed to Patrick Kocian in Volume 760, Page 670 of the Official Records of Lavaca, County, Texas,

S 52°27'43" W -along the northwest line of said 57.69 acre tract, the southeast line of said THENCE:

122.02 acre tract, and the southeast line of this herein described tract at 2329.37 feet past a 1/2" iron rod found for a line marker, in all a total distance of 2393.59 feet, to a point at the west corner of said 57.69 acre tract and in the northeast right of way line of said County

Road 450, for the south corner of this herein described tract;

N 24°51'56" W -along the northeast right of way line of said County Road 450, the southwest THENCE: line of said 122.02 acre tract, and the southwest line of this herein described tract at 1416.93

feet past a 1/2" iron rod found for a line marker, in all a total distance of 1474.32 feet, to the POINT OF BEGINNING, containing within these metes and bounds a 61.036 acre tract,
