All that certain lot, tract, or parcel of land situated in the Manuel Riondo Survey Abstract 25, Freestone County, Texas, being the residue of a called 95-6/7 acre tract described by deed recorded in Volume , Page and being all of a called 90.99 acre tract, as occupied, described by deed recorded in Volume , Page of the Deed Records of Freestone County, Texas. Said tract or parcel being more particularly described by metes and bounds as follows;

BEGINNING on a found 6" wood post for the northeast corner of this tract and the northeast corner of the above mentioned 90.99 acre tract located in the west margin of Freestone County Road 240, said point being the southeast corner of an 82.20 acre tract recorded in Volume 1642, Page 328;

THENCE with said road S01°17'07"W 2381.03 feet to the southeast corner of this tract; Witness: N82°00'00"W 29.9 feet, a set 1/2" iron rod.

THENCE with the line of directional control N82°00'00"W 1583.33 feet to a found T-Bar for the most southerly southwest corner of this tract and the southwest corner of said 90.99 acre tract;

THENCE NORTH 532.35 feet to a found T-Bar for an ell corner of this tract and the southeast corner of said 95-6/7 acre tract;

THENCE N88°42'41"W 1545.64 feet to a found T-Bar for the southeast corner of a 3.943 acre tract recorded in Volume 1645, Page 545;

THENCE with the northeast line of said 3.943 acre tract N39°34'26"W 153.93 feet to a found 3/8" iron rod, N56°19'42'W 89.22 feet to a found 3/8" iron rod, N13°42'11"W 128.50 feet to a found 3/8" iron rod, N87°42'51"W 80.57 feet to a found 3/8" iron rod, N56°48'38"W 166.58 feet to a found 3/8" iron rod, N34°42'27"W 76.10 feet to a found 3/8" iron rod and N62°36'44"W 81.30 feet to a found T-Bar for the northwest corner of said 3.943 acre tract;

THENCE with the west line of this tract N11°22'44"E 1250.45 feet to a found T-Bar and N11°25'46"E 268.33 feet to a found T-Bar for the northwest corner of this tract and the southwest corner of said 82.20 acre tract;

THENCE S88 $^{\circ}$ 43'12"E 1804.25 feet to a found 1/2" iron rod for an ell corner of said 82.20 acre tract;

THENCE S01° 16'48"W 99.26 feet to a found 8" wood post for an ell corner of said 82.20 acre tract;

THENCE with the occupied fence line of said 82.20 acre tract N80°16'36"E 231.60 feet, N85°21'36'E 140.55 feet, S83°27'38"E 181.89 feet, S78°04'36"E 195.64 feet, S76°20'39"E 251.90 feet, S75°13'42"E 401.58 feet and S72°47'02"E 240.50 feet to the place of beginning and containing 176.17 acres of land.
