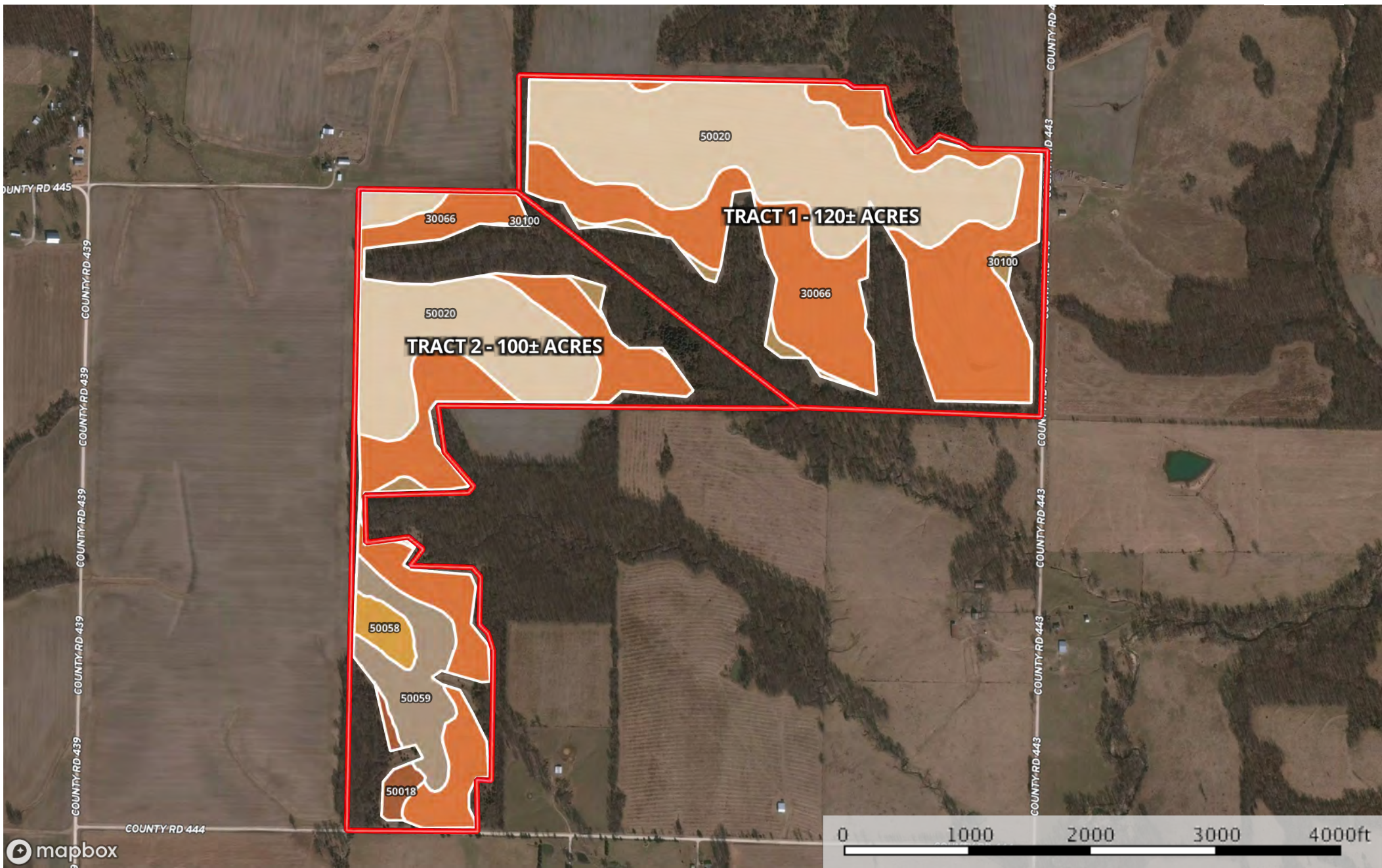


Pike County_Miller Auction Aerial
