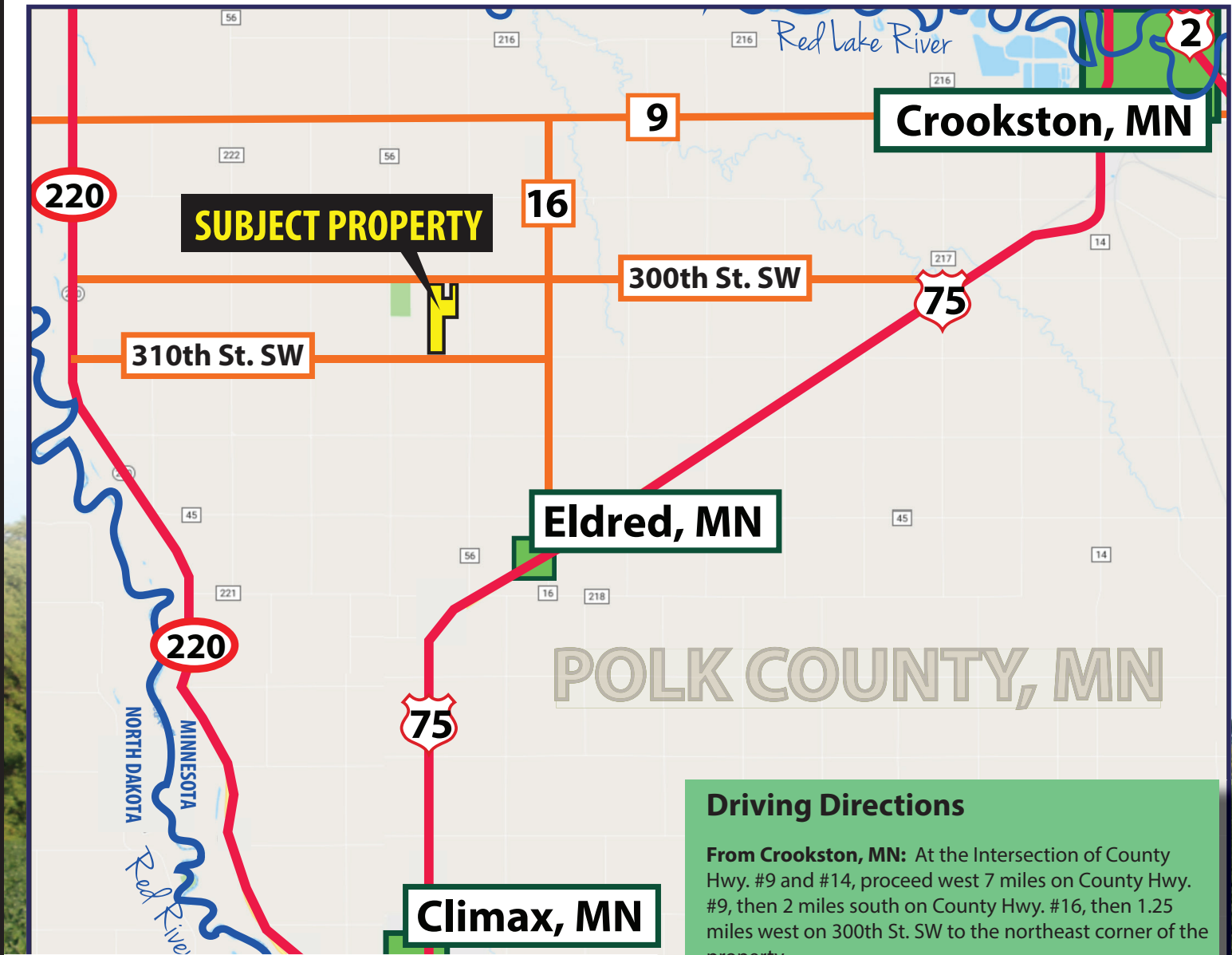

Auction Note: Exceptional cropland in Roome Township in Polk County, Minnesota. This cropland features a Soil Productivity Index (SPI) of 91.1 with mostly Colvin-Perella silty clay loam soils ideal for productive crop rotation. This is notably some of the most productive land in the Red River Valley.

From Crookston, MN: At the Intersection of County Hwy. #9 and #14, proceed west 7 miles on County Hwy. #9, then 2 miles south on County Hwy. #16, then 1.25 miles west on 300th St. SW to the northeast corner of the property.

From Climax, MN: Proceed north and east 5 miles on Minnesota Hwy. #75, then 3 miles north on County Hwy. #16, then 1.25 miles west on 300th St. SW to the northeast corner of the property.

From Eldred, MN: Proceed north 3 miles on County Hwy. #16 then 1.25 miles west on 300th St. SW to the northeast corner of the property. You may access the southern portion of the property by taking 310 St. SW off County Hwy. #16.

Terms and Conditions

I. Terms and Conditions of Auction

A.
