Field Notes Description

49.90 acres out of the M.A. Williams Survey, Abstract 82, being out of a 196.83 acre tract conveyed by the H.A. Furrh Estate to Annabelle Furrh, Trustee of the H.A. Furrh Bypass Trust, and described in Warranty Deed dated June 12, 1972 and recorded in Volume 383, Page 335 of the Deed Records of Gonzales County, Texas.

Being more fully described by metes and bounds as follows:

COMMENCING: at a 5/8" iron rod, (Y = 13,774,780.84, X = 2,510,909.83), found on the west right of way line of a public road conveyed to Gonzales County in Volume 1098, Page 013 of the Official Records of Gonzales County, Texas, on the north line of a 109.60 acre tract conveyed to Alton Kiefer in Volume 937, Page 753 of the Official Records of Gonzales County, Texas, at the southeast corner of a 71.16 acre tract conveyed to Kevin Hermann in Volume 1260, Page 463 of the Official Public Records of Gonzales County, Texas;

THENCE: N 24°00'27" E -77.45 feet to the POINT OF BEGINNING, a 5/8" iron rod with cap stamped "RPLS 6368" set on the east right of way line of said public road, at an exterior corner on the west line of a 25.10 acre tract, dually surveyed, for the northwest corner of this herein described tract;

THENCE: S 38°54'58" E -76.70 feet along a west interior line of said 25.10 acre tract and an east line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at a southwest interior corner of said 25.10 acre tract, for the northwester corner of this herein described tract;

THENCE: S 05°13'15" E -178.83 feet along a west interior line of said 25.10 acre tract and an east line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the southwest corner of said 25.10 acre tract, for an interior corner of this herein described tract;

THENCE: N 84°46'45" E - along the south line of said 25.10 acre tract and the north line of this herein described tract, at 859.09 feet pass a 5/8" iron rod with cap stamped "RPLS 6368" set, in all a total distance of 1,129.59 feet to a 5/8" iron rod with cap stamped "RPLS 6368" set, at the northwest corner of a 22.27 acre tract, dually surveyed, on the south line of a 27.17 acre tract, dually surveyed, for the northeast corner of this herein described tract;

THENCE: S 00°28'03" W - along the west line of said 22.27 acre tract and the east line of this herein described tract, at 555.63 feet pass a 5/8" iron rod with cap stamped "RPLS 6368" set at the southwest corner of said 22.27 acre tract and the northwest corner of a 23.00 acre tract, dually surveyed, at 1, 184.85 feet pass a 5/8" iron rod with cap stamped "RPLS 6368" set at the southwest corner of said 23.00 acre tract and the northwest corner of a 26.00 acre tract, dually surveyed, in all a total distance of 1,896.74 feet to a 5/8" iron rod with cap stamped "RPLS 6368" set at the southwest corner of said 26.00 acre tract, on the north line of a 23.42 acre tract conveyed to Lenore Mitchell Estate in Volume 158, Page 205 of the Official Records of Gonzales County, Texas, for the southeast corner of this herein described tract;

THENCE: S 88°48'31" W -709.10 feet along the north line of said 23.42 acre tract and the south line of this herein described tract to a fence post found at the northwest corner of said 23.42 acre tract and at the northeast corner of a 24.42 acre tract conveyed to Benard Mitchell in Volume 334, Page 347 of the Official Records of Gonzales County, Texas, for an angle corner in the south line of this herein described tract;

THENCE: N 89°46'04" W -412.35 feet along the north line of said 24.42 acre tract and the south line of this herein described tract to a fence post found at the southeast corner of an 88.00 acre tract conveyed to Stelton Mitchell in Volume 258, Page 182 of the Official Records of Gonzales County, Texas, for the southwest corner of this herein described tract;

THENCE: N 03°05'24" W -606.93 feet along the east line of said 88.00 acre tract and the west line of this
