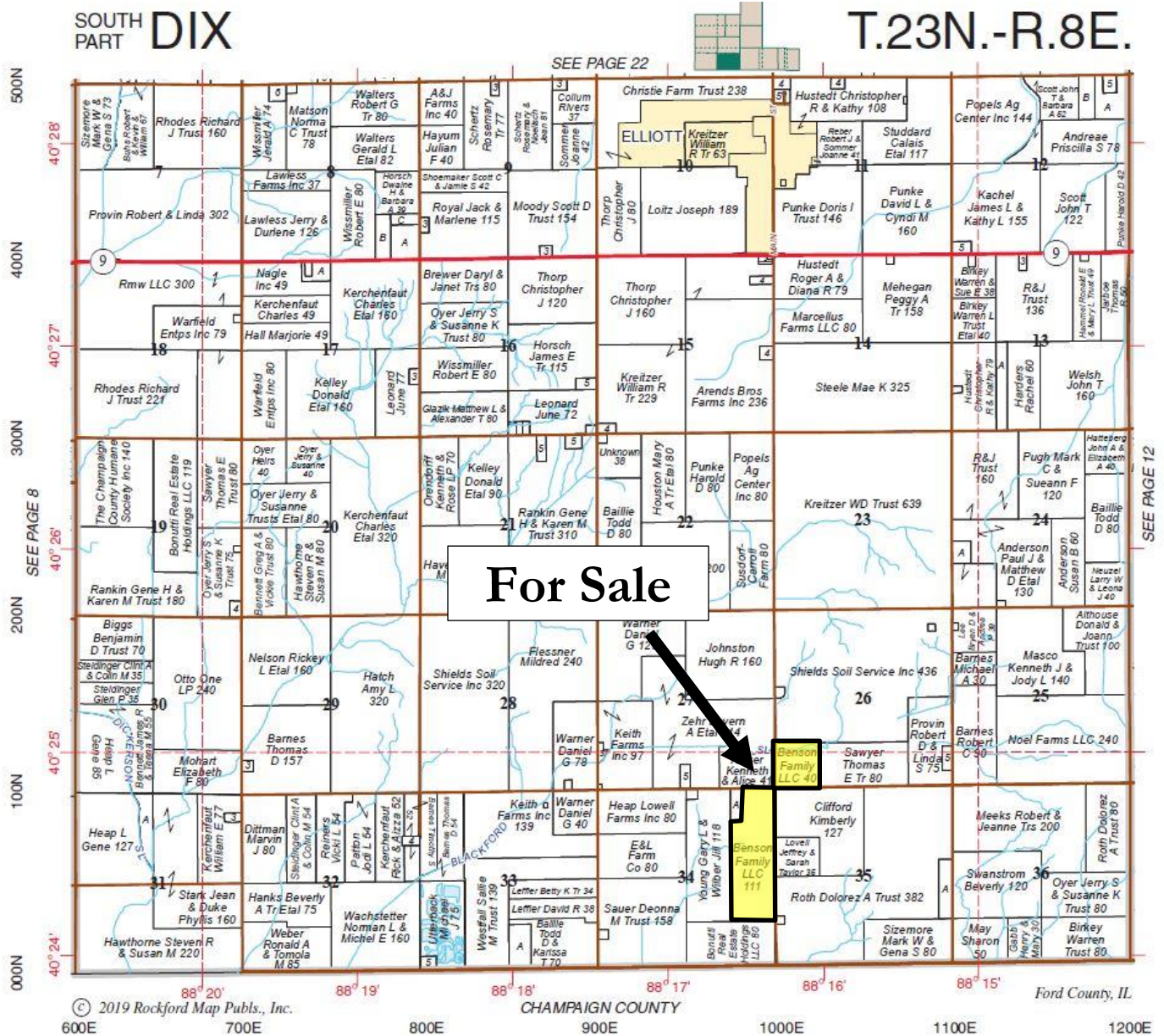

Plat Map

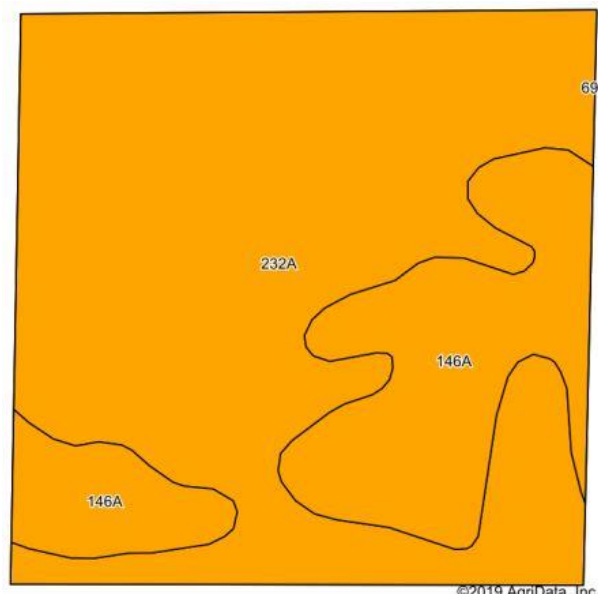

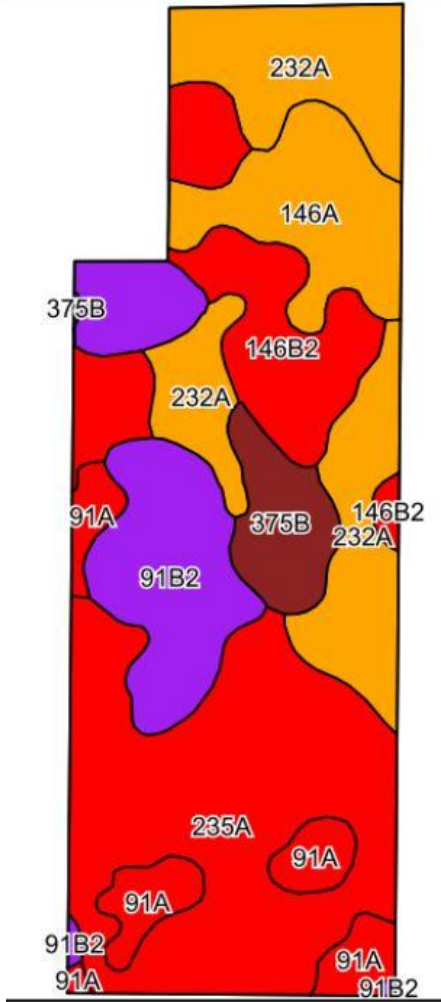

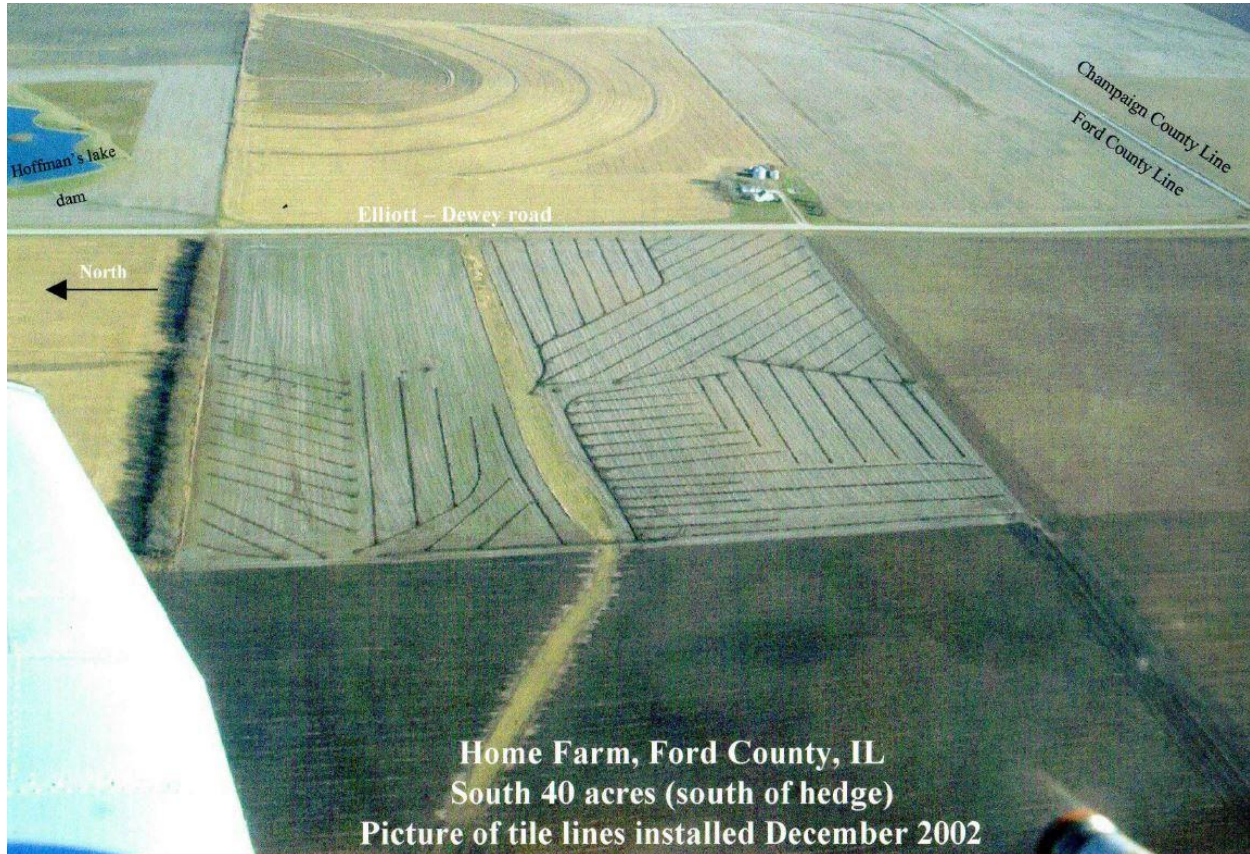
