Construction Features:

- 6" slab with ½" rebar on 12" centers
- Every 10' is a 10" x 10" beam on 12" center also built with ½" rebar
- Walls built with 2" x 6" studs
- Foundation included 54 loads of base creating a pad of approx. 4 feet of compacted caliche
- Installed French drain of 3" Schedule 40 PVC which runs north and south under the caliche to drain water from the foundation to the creek
- Water lines in the slab were installed in a 4" chase inside the compacted base. There are no pipes in the dirt, all are encased in the chase
- All water lines are CPVC in 100' rolls
