for and in consideration of the sum of TEN AND NOVEMBRE DOLLARS
(\$10.00) and other valuable consideration to the undersigned paid
by the Grantee herein named, the receipt of which is hereby ac-
knowledged, and for the further consideration of the execution and
delivery by Grantor of his one certain promissory note of even
date herewith in the principal amount of \$12910.00 ;

\$1 TWELVE THOUSAND NINE HUNDRED TEN & 00/100 DOLLARS,
payable to the order of Grantor as therein provided and bearing
interest at the rates therein specified and containing the usual
clauses providing for acceleration of maturity in event of de-
fault and for attorney's fees, and being secured by a first and
superior vendor's lien and superior title herein and hereby ex-
clusively retained and reserved upon the property herein conveyed,
and being additionally secured by a deed of trust thereon of even
date herewith to G. Bryan Stowers, Jr., Trustee, has GRANTED,
HOLD and CONVEYED, and by these presents does GRANT, SELL and
CONVEY unto ALBERT ALLEN JR. & DIANE M ALLEN
herein called "Grantee," whether one or more, of BEXAR
County, Texas, all of the following-described real property in
MEDINA County, Texas, together with all improvements located
thereon, to wit:

Lot 14, Block 8, MEDINA RIVER WEST PHASE II, a subdivision in
MEDINA County, Texas, according to the map or plat thereof
recorded in Book T, Pages 19-21, Plat Records of MEDINA County,
Texas (the "Property").

TO HAVE AND TO HOLD the Property, together with all and con-
siderable the rights and appurtenances thereto in any wise belonging,
unto Grantee, his heirs and assigns forever; and Grantor gets
hereby bind itself, his successors and assigns to WARRANT AND

pared, the payment thereof is assumed by Grantee.

these certain Deed Restrictions recorded in Volume 34, Page 378-379,
Deed Records of MEDINA County, Texas; and that those royalty
interests, mineral interests, and other interests in oil, gas
other minerals, whether participating or non-participating,
tech or per cent, which have heretofore been conveyed to or
reserved by others and are of record in MEDINA County, Texas, this lot is sold
