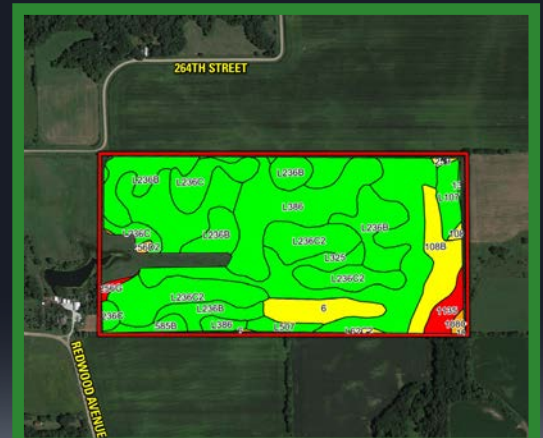
ABOUT THE FARM

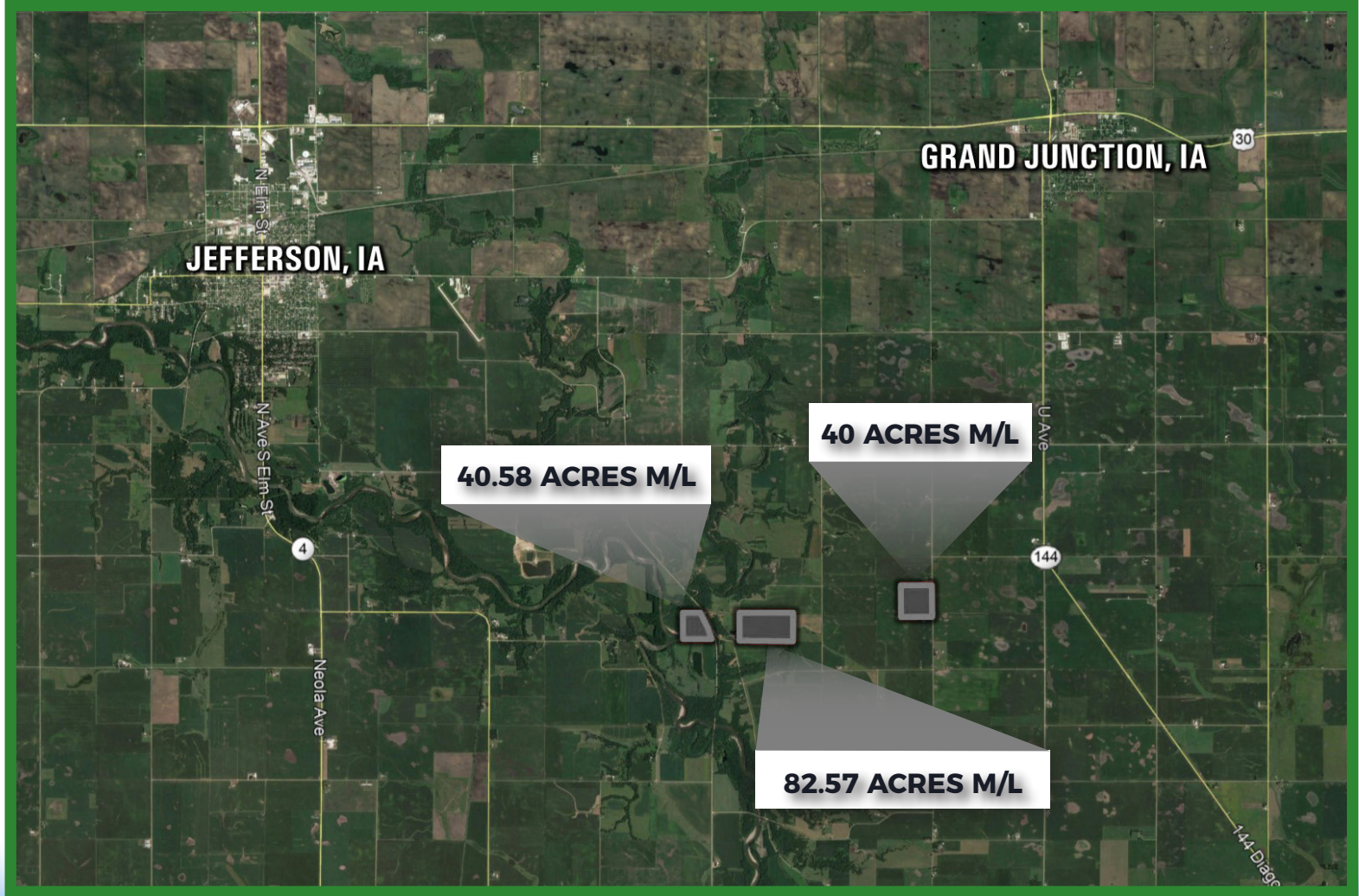
