Being a 14.966 acre tract situated in the Richard Meade Survey 1225, Abstract 576, Atascosa County, Texas, and being that same 15 acre tract as recorded in Volume 177, Page 77, Official Public Records of Atascosa County, Texas; said 14.966 acre tract surveyed by Jeffrey B. Berger, R.P.L.S. No. 5558 on May 20, 2005 and being more particularly described as follows:

BEGINNING at a 1/2" steel rod found on the northeast line of State Highway 173 for the west corner of said 15 acre tract and the herein described tract;

THENCE North 19° 37' 28" East 1284.63 feet (called North 19° 37' 28" East 1285.00 feet) (Reference Bearing) along a barbed fence with the northwest line of said 15 acre tract to a 1/2" steel rod found for the north corner of said 15 acre tract and the herein described tract:

THENCE South 69° 58' 12" East 507.90 feet (called South 70° 13' 29" East 508.50) along a barbed wire fence with the northeast line of said 15 acre tract to a 1/2" steel rod found for the east corner of said 15 acre tract and the herein described tract;

THENCE South 19° 37' 47" West 1282.81 feet (called South 19° 37' 38" West 1285.00 feet) along a barbed wire fence with the southeast line of said 15 acre tract to a 1/2" steel rod found for the south corner of said 15 acre tract and the herein described tract;

THENCE North 70° 10' 33" West 507.78 feet (called North 70° 30' 29" West) along a barbed wire fence with said northeast line of State Highway 173 and the southwest line of said 15 acre tract to the POINT OF BEGINNING and containing 14.966 acres or 651,914 square feet, more or less.
