TIMBER:

The property consists of 2 timber stands. Stand 1 consists of+/- 23 acres of pine plantation planted in 1993. Stand 1 was first thinned in 2016. Stand 2 consists of +\- 6 acres of streamside management zones. Approximately 2 acres lies in the state highway right-of-way and approximately 1 acre is being adversely possessed south of the state highway on the west side.

Baker Land & Timber Management, Inc. installed 22 - 10BAF prism plots on stand 1. Stand 2 had 6 - 1/5th acre sawtimber and 1/10th acre pulpwood plots installed. Both stands were cruised in November, 2018. The cruise numbers listed below is the estimated timber volumes by product class.
