







A DESCRIPTION OF A 0.083 ACRE TRACT OF LAND BEING A PORTION OF THAT CERTAIN 17.4 ACRE TRACT OF LAND DESCRIBED IN CLERK'S DOCUMENT NO. 20175636, OFFICIAL PUBLIC RECORDS OF GILLESPIE COUNTY, TEXAS, SAID 0.083 ACRE AS SHOWN ON THE ACCOMPANYING MAP BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:


BEGINNING at a four (4) inch metal fence post found for the southwest corner of said 0.083 acre, being in the south line of said 17.4 acres and being in the north line of that certain 576.27 acre tract of land described in Clerk's Document No. 20173126 of the Official Public Records, of said county;

THENCE along the west line of said 0.083 acre, crossing said 17.4 acres, N24°11'53"W, 758.53 feet to a four (4) inch metal fence post found, and N55°40'56"W, 44.20 feet to a four (4) inch metal fence post found for the northwest corner of said 0.083 acre, being in the north line of said 17.4 acres and being in the south line of Feller Hahn Road (county road);

THENCE along the north line of said 0.083 acre, being the north line of said 17.4 acres and being the south line of said Feller Hahn Road, N78°03'13"E, 31.72 feet to a calculated point for the northeast corner of said 0.083 acre, being the northeast corner of said 17.4 acres and being an ell corner of said Feller Hahn Road;

THENCE along the east line of said 0.083 acre, being the east line of said 17.4 acres and being the west line of said Feller Hahn Road, S24°10'39"E, 788.37 feet to a calculated point for the southeast corner of said 0.083 acre, being an east corner of said 17.4 acres and being in the north line of said 576.27 acres;

THENCE along the south line of said 0.083 acre, being the south line of said 17.4 acres and being the north line of said 576.27 acres, S56°52'57"W, 7.72 feet to the **POINT OF BEGINNING**, containing 0.083 acre of land, more or less.
