- 1. All homes must be permanent type on—site built homes. No mobile homes (single or double—wide) or any type of trailer, campers, shacks, or temporary structures of any kind will be allowed.
 - 2. All structures must be a minimum of 1100 square feet of heated space.
- Lots shall be used for residential purposes only, and no commercial buildings or use shall be permitted on any lot.
- 4. No disabled, dismantled, or inoperative motor vehicles of any kind shall be stored or located on any lot; no trash, debris, garbage, or the like shall be permitted on any lot, except normal household trash in appropriate trash containers.
- 5. All outbuildings, boat houses, detached vehicle garages, or storage buildings, shall be equal to or greater than the type construction as the main house, including type and quality of materials, construction and labor.
 - 6. All electrical service lines shall be underground form street to home.
- 7. Water supply for all lots shall be wells constructed for the production of water from underground surfaces by a state approved licensed Water-Well Contractor.
- 8. All homes must comply with the rules and regulations of the State of Tennessee Department of Environment and Conservation Divisions of Ground Water Protection and Water Supply, Tennessee Valley Authority regulations, where applicable, U.S. Army Crops of Engineers regulations, where applicable, and flood hazard regulations developed by Hickman County, Tennessee under the National Flood Insurance Program regulating building and construction within the 100 year flood plan areas of said county.
