Metes & Bounds Property Description

Tract 2

A tract of land containing 11.0000 Acres situated in the Samuel C. Hady Survey, Abstract No. 31, Waller County, Texas, being a portion of a tract recorded in the name of Timothy J. Phelan under Document No. 2001021 of the Official Public Records of Waller County, Texas (O.P.R.W.C.T.), and being more particularly described by metes and bounds as follows: (Bearings based on said Document No. 2001021 of the O.P.R.W.C.T.)

COMMENCING at an iron rod found at the intersection of the southerly right-of-way line of FM 1458 Road (variable width) and the easterly right-of-way line of Clemons Switch Road, being the northwesterly corner of said Phelan Tract;

THENCE, SOUTH 34° 30' 13" WEST, with said easterly right-of-way line, passing at a distance of 946.59 Feet a 1/2 Inch iron rod with a "Precision" cap set, passing at an additional 600.83 Feet a 1/2 Inch iron rod with a "Precision" cap set, and continuing for an additional distance of 240.28 Feet for a total distance of 1,787.70 Feet to a 1 Inch iron pipe found;

THENCE, SOUTH 34° 00' 00" WEST, continuing with said easterly right-of-way line, a distance of 677.44 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the northwesterly corner and POINT OF BEGINNING of this tract;

THENCE, SOUTH 55° 06' 45" EAST, across and through the aforementioned Phelan Tract, passing at a distance of 400.00 Feet a 60d nail set and continuing for a total distance of 829.68 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the northeasterly corner of this tract;

THENCE, SOUTH 34° 45' 56" WEST, with the westerly line of a tract recorded in the name of Cynthia Ann Brubanker in Volume 411, Page 496 of the O.P.R.W.C.T., a distance of 580.24 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the southeasterly corner of this tract;

THENCE, NORTH 55° 06' 45" WEST, across and through the aforementioned Phelan Tract, passing at a distance of 421.93 Feet a 60d nail set and continuing for a total distance of 821.93 Feet to a 1/2 Inch iron rod with a "Precision" cap set on the aforementioned easterly right-of-way line of Clemons Switch Road at the northwesterly corner of this tract;

THENCE, NORTH 34° 00' 00" EAST, with said easterly right-of-way line, a distance of 580.30 Feet to the POINT OF BEGINNING and containing 11.0000 Acres of land.
