THENCE continuing across said 80-1/2 acre Patschke First Tract, with the West line of said 68.000 acre Tract 4 this day surveyed, **South 07 deg. 27 min. 19 sec. East- 1390.70 feet** to a 5/8 inch rebar with cap marked "4428" set in the Northeast line of said Gage Survey, the Southeast line of said Kesler Survey, the Northeast line of said 100 acre Patschke Second Tract, the Southeast line of said 80-1/2 acre Patschke First Tract, for an angle point of said 68.000 acre Tract 4 this day surveyed, and an angle point hereof;

THENCE across said 100 acre Patschke Second Tract, with the Southwest line of said 68.000 acre Tract 4 this day surveyed, **South 18 deg. 33 min. 54 sec. East – 1752.84 feet** to a 5/8 inch rebar with cap marked "4428" set in the Northwest line of said 441.929 acre Russell tract, the Southeast line of said 100 acre Patschke Second Tract, for the South corner of said 68.000 acre Tract 4 this day surveyed, and the East corner hereof;

THENCE with the Northwest line of said 441.929 acre Russell tract, the Southeast line of said 100 acre Patschke Second Tract, **South 66 deg. 46 min. 21 sec.** West – 1336.42 feet t to the PLACE OF BEGINNING and containing 84.530 acres of land.
