**CONDITIONS OF APPROVAL**

1. The right holder shall maintain a measuring device of a type approved by the Department as part of the diverting works.
2. This right when combined with all other rights shall provide no more than 0.02 cfs per acre nor more than 3.5 afa per acre at the field headgate for irrigation of the lands above.
3. Rights 22-7373 and 22-7349 when combined shall not exceed the irrigation of 861 acres.
4. Use of this right is combined with water from Fremont-Madison Irrigation District.
5. Use of water under this right will be regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No. 1.

This license is issued pursuant to the provisions of Section 42-219, Idaho Code. The water right confirmed by this license is subject to all prior water rights and shall be used in accordance with Idaho law and applicable rules of the Department of Water Resources.
