S 89° 59' 52" E - 112.05 feet.

THENCE S 89° 59' 52" E with the North line of the residue 512.085 acre tract and the upper South line of said 148.172 acre tract a distance of 1314.67 feet to a 1/2" Iron Rod found for corner at an interior corner of said 148.172 acre tract.

THENCE S 38° 16' 30" E with a Northeast line of the residue of said 512.085 acre tract and the upper Southwest line of said 148.172 acre tract a distance of 882.51 feet to a 1/2" Iron Rod found for corner at an interior corner of said 148.172 acre tract.


