**BEGINNING** at a ½" iron rod found with a plastic cap imprinted with "Holt Carson, Inc." in the West line of that certain (137.115 acre) tract of land as conveyed to Archie L. Paul and described in Volume 1073 Page 381 of the Deed Records of Travis County, Texas, and in the East line of Lot 6, Milam Ranch Subdivision, a subdivision in Travis County, Texas, according to the map or plat thereof recorded in Volume 4 Page 340 of the Plat Records of Travis County, Texas, for the Northwest corner of that certain (107.06 acre) tract of land as conveyed to Frederic L. Paul by Special Warranty Deed recorded in Document No. 2017008979 of the Official Public Records of Travis County, Texas, and for the Southwest corner of that certain (107.06 acre) tract of land as conveyed to Marlee Jane Peurifoy and James R. Greenberg by deed recorded in Volume 8817 Page 516 of the Deed Records of Travis County, Texas, and being a Westerly angle corner of this tract;

THENCE with the common line of said Greenberg (8.946 acre) tract and said Paul (208.33 acre) tract, although deviating from the South lines of Lots 15 and 14, Milam Ranch Subdivision, N 65 deg. 19' 42" E 1332.72 ft. to an inundated point in a slough of the Pedernales River for the Southwest corner of Lot 13 and the Southeast corner of Lot 14, of said Milam Ranch Subdivision, and being an angle corner of this tract;

THENCE with the South line of said Lot 13, N 44 deg. 59' 20" E at 16.47 ft. passing a 1" iron rod found and continuing with the same bearing for a total distance of 340.41 ft. to a square metal rod found in a concrete monument on the North side of a very deep slough for the Southeast corner of said Lot 13 and being an angle corner of this tract;
