RE: Template Test (TT #16-09) for an approximate 37.80 acre property associated with current Tax Map ID Number 6211-00-00102

Tax Map ID #6211-00-00102 was determined to be a legal lot of record by Columbia County Land Development Services per LRD 08-06, LRD 08-07 and LRD 08-08. Since the 37.80 acre property in the Primary Forest (PF-80) zone is a historic lot of record, it can be reviewed for home authorization under the template test criteria. The template test you requested for Tax Map ID #6211-00-00102 has been completed. According to the attached Template Test map, this property meets the minimum requirements of Oregon Administrative Rule 660-006-0027(1)(f) and Section 506.4 of the Columbia County Zoning Ordinance.

According to the <u>Soil Survey of Columbia County</u>, <u>Oregon</u>, the soils on the 37.80 acre tract consist of Goble Silt loam, soil types 23C&D. The growth at the culmination of the mean annual increment (CMAI) for Douglas-fir production for Goble Silt loam is 183 cubic feet per acre. A forest dwelling on this soil requires all or part of at least eleven (11) other lots of parcels and three (3) dwellings that existed on January 1, 1993 to be within a 160 acre template centered on the subject tract.




