Enclosed is a new contract. If you choose to continue this service, just sign the contract and return it with payment. The contract renews and is billed annually. The cost is \$175 per year. For an additional \$50 per year (\$70 per year for commercial properties), we will supply the chlorine for your system and add it during each visit. Annual fee is guaranteed for one year. We will mail you an invoice when your year expires. A copy of the contract will be forwarded to the permitting authority, and we will continue providing you with maintenance as stated in the contract.

## **Inspection and Maintenance Agreement**

Randy's Septic Service, a state licensed and certified aerobic maintenance provider, hereby enters into a contract with the owner of the property addressed below to inspect and service the aerobic system and its components starting 5/1/2019. Randy's Septic Service will make three inspections per year (every 4 months) for residential systems and four inspections per year (every 3 months) for commercial systems. Service is paid for in advance and billed annually. Payments are non-refundable. Property owner may cancel the service at any time via verbal or written notices to Randy's Septic Service or by lack of payment.

Add Chlorine (check if you would like Randy's Septic Service to provide chlorine tablets at each visit for an additional \$50 per year for residential properties or \$70 per year for commercial properties)

Company will inspect, service, and clean as needed the following items:

- Aerators and their filters,
- Pumps and their filters,
- Diffusers, Disinfection Device, and Chlorine Supply,
- Electrical components and circuits,
- Distribution system including spray heads, valves, etc. (as applicable).

Company will check aerobic and pump tanks for scum, sludge levels, turbidity, color and odors. A chlorine residual test will be conducted each scheduled visit and a BOD test will be conducted once a year.

Company will respond to any service calls within 48 hours should the situation occur. The property owner will be financially responsible for paying for the service call and for any repairs made to the system excluding repairs covered under the system warranty.

Adding chlorine to the chlorinator is the responsibility of the homeowner. Company will do this at the request of the homeowner and at an additional charge.

Company will mark the system's inspection tag with the date of each service call. A copy of the service report will be left on-site, and a copy will be mailed to the local permitting agency within 30 days when required.

If the Company desires to terminate this contract, or if the owner desires to renew this contract with another company, notification must be made by both parties to the permitting agency no later than 30 days prior to the change of contract status.
