THENCE, N 10°31'19" W, along the West line of said Bozka 4.5 acre tract, a distance of 250 feet to a capped 1/2" iron rod set for the northwest corner of said 0.6 acres;

THENCE, N 80°07'42" E, a distance of 73 feet to a capped 1/2" iron rod set for the northeast corner of said 0.6 acres:

THENCE, S 12°22'04" E, a distance of 39.47 feet to a capped 1/2" iron rod set for an interior corner of said 0.6 acres;

THENCE, N 75°42'28" E, a distance of 31 feet to a capped 1/2" iron rod set for the lower northeast corner of said 0.6 acres:

THENCE, S 14°42'10" E, a distance of 205.35 feet to a capped 1/2" iron rod set in the South line of said Bozka 4.5 acre tract, same being the lower southwest corner of a 3.98 acre tract surveyed this day and in said North line of the public road, same also being the southeast corner of said 0.6 acres:
