## **164.30 ACRE TRACT**

**Field Notes Description** 

164.30 acres of land out of the J. McGown Survey, Abstract 458 and the W. Kuykendall Survey, Abstract 219, Fayette County, Texas, being that same land described as "Tract One" and "Tract Two" and conveyed by Virginia McCrory Gover to Judith M. Temple and Timothy Glen Horgan in Gift Deed dated August 16, 2003 and recorded in Volume 1237, Page 430 of the Official Records of Fayette County, Texas.

Being more fully described by metes and bounds as follows:

- **BEGINNING:** at a 1/2" iron rod, (**Y** = 13,819,182.80, **X** = 2,543,134.45), found at the northwest corner of a 7.82 acre tract conveyed to Wayne Derry and in the north right of way line of F.M. 2762, for an angle corner of this herein described tract;
- **THENCE:** N 50°08'09" W -2012.53 feet along the north right of way line of said F.M. 2762 and the south line of this herein described tract to an angle point of this herein described tract;
- **THENCE:** N 52°29'00'' W -56.49 feet continuing along the north right of way line of said F.M. 2762 and the south line of this herein described tract to an angle point of this herein described tract;
- **THENCE:** N 53°50'40" W -57.72 feet continuing along the north right of way line of said F.M. 2762 and the south line of this herein described tract to a 3/8" iron rod found at the southeast corner of a 2.0 acre tract conveyed to Michael John Blume in Volume 798, Page 321 of the Deed Records of Fayette County, Texas, for the southwest corner of this herein described tract;
- **THENCE:** N 01°55'25'' W -1717.00 feet along the east line of said 2.0 acre tract and the west line of this herein described tract to a 3/8" iron rod found at the southwest corner of a 118.60 acre tract conveyed to Samuel McCrory in Volume 1910, Page 834 of the Official Records of Fayette County, Texas, for the northwest corner of this herein described tract;
- **THENCE:** N 87°07'44" E -2202.79 feet along the south line of said 118.60 acre tract and the westerly north line of this herein described tract to a 3/8" iron rod found at the southeast corner of said 118.60 acre tract and in a west line of a 154.80 acre tract conveyed to the Tommy B. and Pamela Tipton Trust in Volume 1648, Page 389 of the Official Records of Fayette County, Texas, for an exterior corner of this herein described tract;
- **THENCE:** S 02°52'20" E -235.52 feet along the west line of said 154.80 acre tract and the northerly east line of this herein described tract to a 3/8" iron rod found at the southwest corner of said 154.80 acre tract, for an interior corner of this herein described tract;
- **THENCE:** N 87°20'42'' E -576.62 feet along the south line of said 154.80 acre tract and the easterly north line of this herein described tract to a 1/2" iron rod found at the northwest corner of a 51.98 acre tract conveyed to William and Joyce Rabb in Volume 1738. Page 492 of the

- **THENCE:** S 05°18'09'' W -708.00 feet along the west line of said 43.3 acre tract, (Tract 1), and continuing along the southerly east line of this herein described tract to a 3/8" iron rod found at the northwest corner of a 43.3 acre tract, (Tract 2), conveyed to Sharon (Sigmundik) McKinney in Volume 1255, Page 353 of the Official Records of Fayette County, Texas, for an angle point of this herein described tract;
- **THENCE:** S 05°05'15" W -686.97 feet along the west line of said 43.3 acre tract, (Tract 2), and continuing along the southerly east line of this herein described tract to a 1/2" iron rod found at the southwest corner of said 43.3 acre tract, (Tract 2), and at the northeast corner of said 7.82 acre tract, for the southeast of this herein described tract;
- **THENCE:** N 88°57'20" W -900.27 feet along the north line of said 7.82 acre tract and the south line of this herein described tract to the *POINT OF BEGINNING*, containing within these metes and bounds a 164.30 acre tract, more or less.
