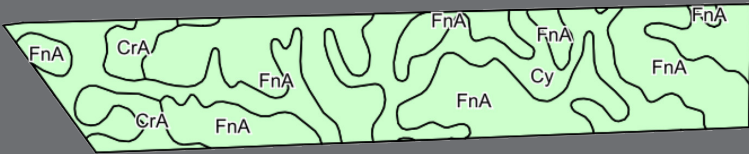

The auctioneer will settle any disputes as to bids and his decision will be final. ACREAGE: The acreage listed in this brochure are estimates taken from the county assessor's records, FSA records and/or aerial photos.
