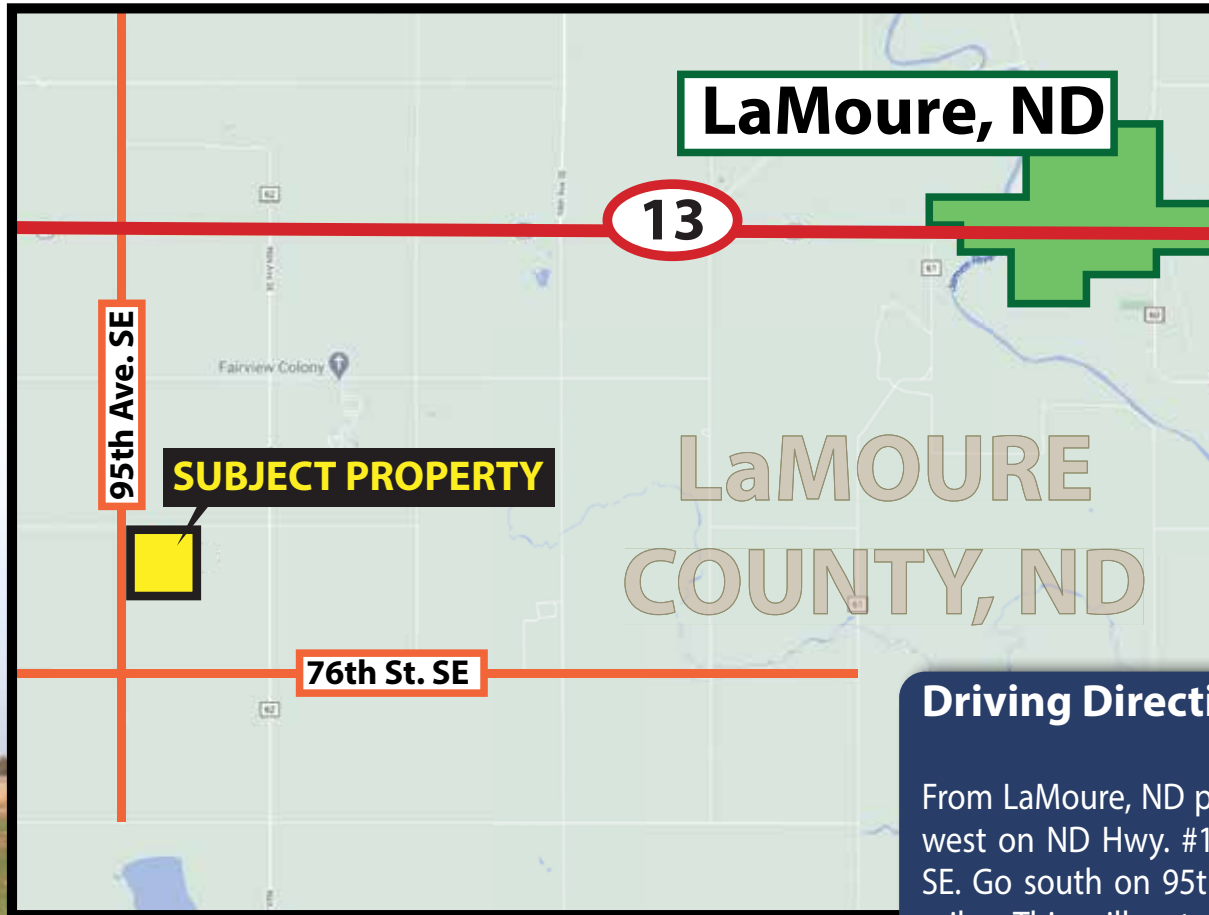

General Information

AUCTION NOTE: This is exceptional cropland, Conservation Reserve Program (CRP) and hunting land in Badger Township in LaMoure County, North Dakota. The cropland is highly productive with a Soil Productivity Index (SPI) of 78.4 and most of the soils are Barnes-Svea Loams. The CRP contracts expire in 2022 and 2023, however, combining the CRP acres with the crop acres give an overall SPI of 74.3! There is an old farm site on the property and a row of evergreens on the north end of the property. The CRP, trees, farm site and wetlands are exceptional habitat for wildlife.

From LaMoure, ND proceed 6 miles west on ND Hwy. #13 to 95th Ave. SE. Go south on 95th Ave. SE for 2 miles. This will put you at the NW corner of the property.

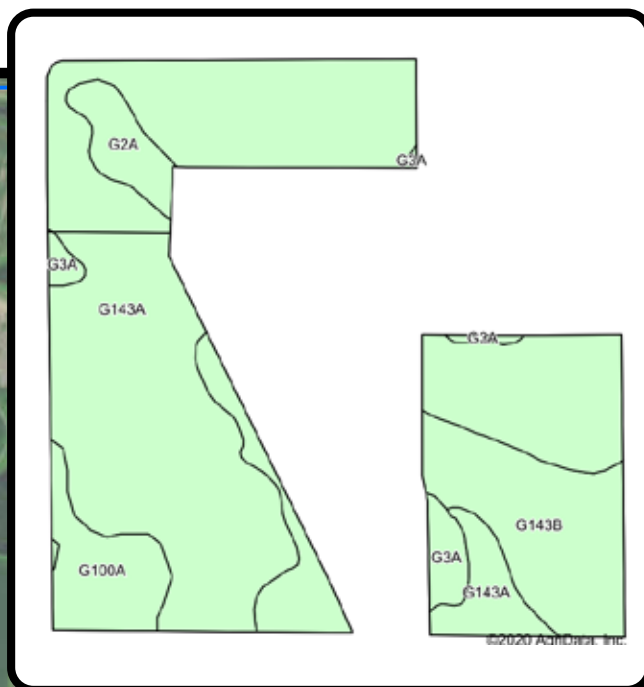
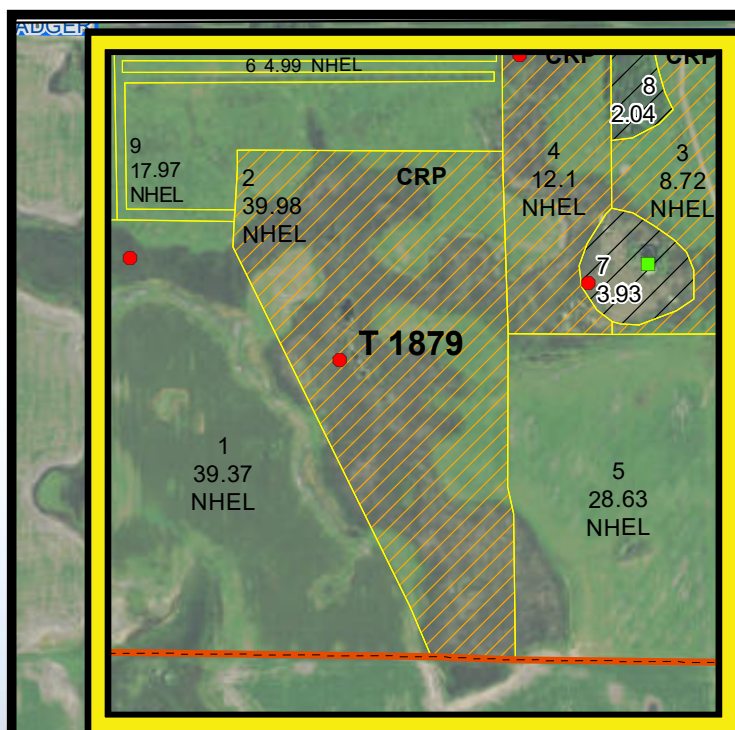

Terms and Conditions

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A.
