Description

Peoples Company is pleased to be representing the sale of Webster County farmland! This affordable tract consists of 60 acres m/l with 57.02 NHEL tillable/farmland acres with a CSR2 rating of 73.7. This nearly 100% tillable farm is located within a great farming community and has convenient access off of US Highway 169.

Several grain marketing options are located nearby offering competitive bidding, including a mix of grain elevators and ethanol plants. The farm is open for the 2021 cropping season. This land would be a great add-on to an existing farming operation or a smart investment for a Buyer looking to diversify their portfolio. The farmland is located approximately three miles southwest of Dayton, lowa, and four miles north of Boxholm, lowa in Section 27 of Dayton Township.

There are two 12" Webster County drainage tile lines located on the parcels directly to the west and south of the farm. Rural water is offered through Xenia Rural Water (8" waterline along the east side of Quail Avenue) and electric service through Midland Power Cooperative (along both 380th Avenue and Quail Avenue) for the farm.


