BEGINNING at an iron rod at a corner post; said point being the NEC of a certain 23.00 acre tract described in a Contract of Sale and Purchase between Veterans Land Board of Texas and Billy Howard Jackson, recorded in Vol. 279, Page 198 of the Deed Records of Bosque County, Texas, for the NEC of this tract;

THENCE S 30-00 E with fence, 614.7 feet to an iron rod in the West right of way of FM Highway No. 216, at the SEC of said 23.00 acres, for the SEC of this tract;

THENCE with fence and the West line of said highway to iron rods as follows: S 32-57 W 25.9 feet; and S 25-33 W 15.9 feet to the SWC of this tract;

THENCE N 89-14 W 275.2 feet to an iron rod, for a corner of this tract;

THENCE N 58-14 W 544.7 feet to an iron rod in the North line of said 23.00 acres, for the NWC of this tract;

THENCE N 58-24 E with fence, 530.5 feet to the place of beginning.
