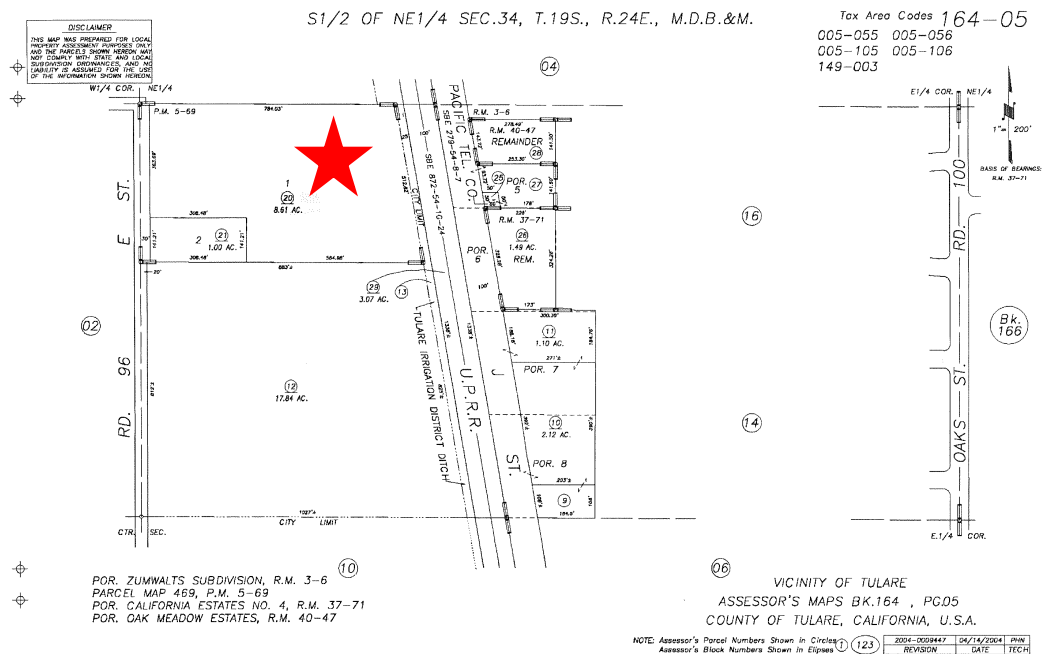
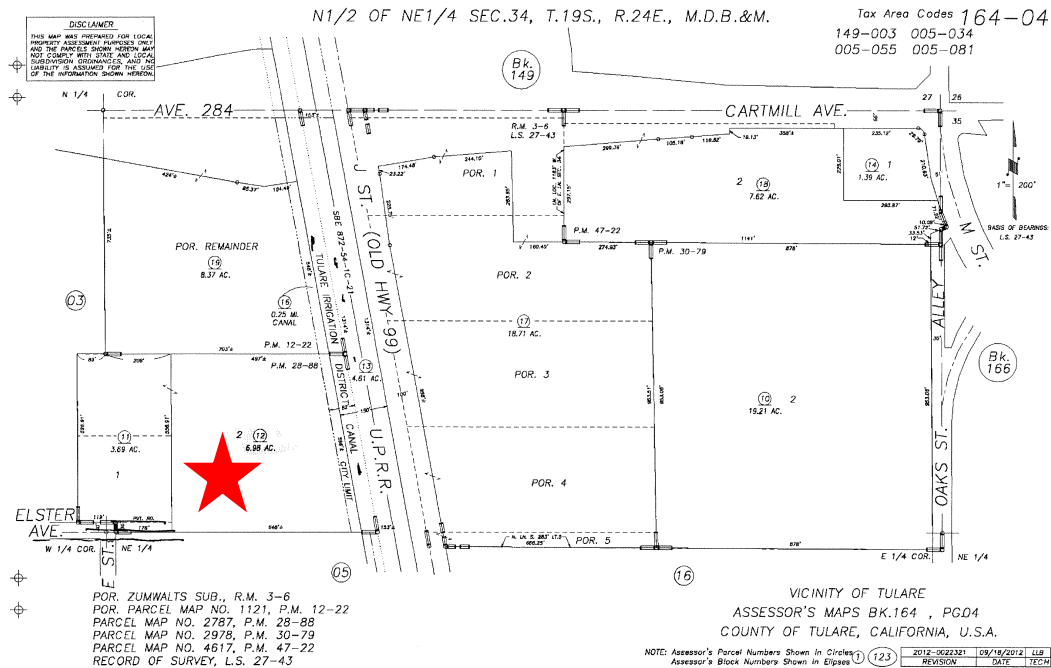

Property Parcel Map

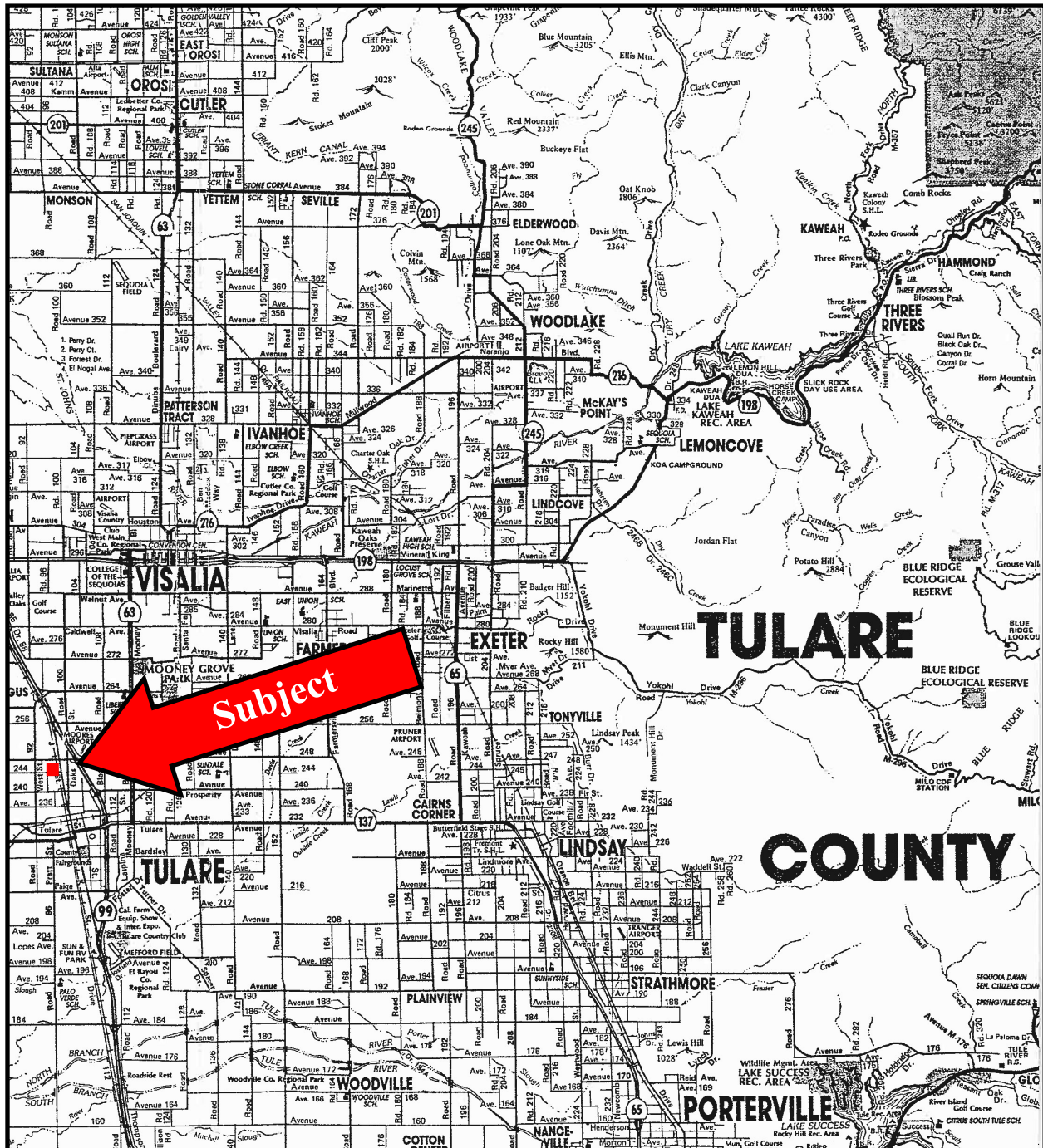
