COMMENCE AT THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 18, T-1-N, R-6-E; THENCE EAST FOR 400.0 FEET; THENCE NORTH FOR 32.0 FEET; THENCE EAST FOR 223.0 FEET TO THE WEST RIGHT-OF-WAY LINE OF AN EXISTING 50' WIDE RIGHT-OF-WAY; THENCE N11°39'00"W FOR 413.43 FEET ALONG SAID WEST RIGHT-OF-WAY LINE TO THE SOUTH RIGHT-OF-WAY LINE OF AN EXISTING 30' WIDE RIGHT-OF-WAY; THENCE WEST FOR 11.65 FEET ALONG SAID SOUTH RIGHT-OF-WAY LINE; THENCE NORTH 30.0 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE NORTH 208.71 FEET; THENCE WEST 208.71 FEET; THENCE SOUTH 208.71 FEET; THENCE EAST 208.71 FEET TO THE POINT OF BEGINNING. 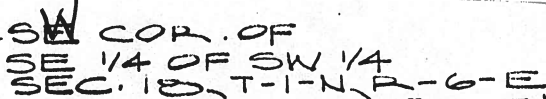
