PROCEDURE FOR OBTAINING ENDORSEMENT OF NOTICE OF INTENTION TO DRILL A WELL

To obtain endorsement from Environmental Services to drill, deepen, replace or modify a well, Coconino County Environmental Quality must determine that there are no onsite wastewater systems within 100 feet of your proposed well. The department must review your application and site plan, make a site visit, and perform a record search of our wastewater files. **Please clearly mark the well site by staking or flagging.**

The following must be submitted before endorsement is given:

- 1. Complete attached application for Notice of Intent to Drill a Well, and submit with the appropriate fee. Make check payable to **C.C.H.D.**
- 2. Submit ADWR Notice of Intention (NOI) form attached.
- 3. Submit site plan (include physical address, landmarks etc.), drawn to scale, as referenced in the NOI instructions. Make sure you include your Assessor's Parcel Number. Also include detailed directions and drawn map to the property by completing the "property locator form".
- 4. Submit appropriate ADWR fee, check payable to ADWR. It will be sent along with your completed NOI forms to the state.

After completing our review, our office will forward all documents to ADWR. There is a 15-day processing time for the ADWR office. (All forms not complete will be returned).
