FIRST AMENDMENT TO RESTRICTIVE COVENANTS FOR

GARDENDALE TERRACE, AN ADDITION TO THE CITY OF GARDENDALE, ECTOR COUNTY, TEXAS, ACCORDING TO THE MAP OR PLAT THEREOF, RECORDED IN CABINET <u>B</u>, PAGE <u>120-B</u> OF THE PLAT RECORDS OF ECTOR COUNTY, TEXAS.

This First Amendment to Restrictive Covenants (the "Amendment") is made this 24th day of September, 2015, by Gardendale Terrace, LLC (the "Developer").

WITNESSETH

WHEREAS, Developer recorded that certain Restrictive Covenants For GARDENDALE TERRACE, AN ADDITION TO THE CITY OF GARDENDALE, ECTOR COUNTY, TEXAS, ACCORDING TO THE MAP OR PLAT THEREOF, RECORDED IN CABINET <u>B</u>, PAGE <u>120-B</u> OF THE PLAT RECORDS OF ECTOR COUNTY, TEXAS, filed of record in Ector County, Texas on October 29, 2014 as Document No. 2014-00016562 (the "Declaration"), with respect to the above referenced property (the "Subdivision").

WHEREAS, Section 8.1(a) of the Declaration grants Developer the exclusive authority to amend the terms of the Declaration with respect to the matters addressed in this Amendment until at least seventy-five percent (75%) of the acreage, which has been or will be platted for residential use in the Subdivision has been sold (the "Developer Control Period").

WHEREAS, as of the date of this Amendment, the Developer Control Period has not expired.

NOW THEREFORE, the Declaration is amended as follows:

A. Section 2.2 of the Declaration is deleted in its entirety and replaced with the following:

No building shall be erected on any residential Lot except one single-family dwelling and outbuildings incidental to and used in connection with the one single-family dwelling. An "outbuilding" shall be defined to include a garage, game room, equine stable, workshop and other buildings necessary for the convenience and pleasure of the occupants of the single-family dwelling erected on the Lot. All such

buildings shall be of a design aesthetically compatible with that of the residence erected on the Lot. Outbuildings shall not include any manner of portable building.

- B. Section 2.9 of the Declaration is deleted in its entirety.
- C. <u>Section 2.22</u> of the Declaration is deleted in its entirety and replaced with the following:

No animals of any kind shall be raised, bred, or kept on any Lot except dogs, cats, horses, or similar domesticated animals provided that they are not kept, bred, or maintained for any commercial purpose.

- D. <u>Severability</u>. The provisions of this Amendment are severable and the invalidity of one or more of the provisions (or any portions thereof) shall not affect the validity or enforceability of any other provisions (or portions thereof).
- E. <u>Effect of Amendment</u>. Except as modified by this Amendment, the Declaration shall remain in full force and effect.
