

# SECTION 15, T 15 S, R 3 E, SLB&M

#### NARRATIVE

This survey was conducted to establish visual boundary lines of the parcel described below. The original boundary line was surveyed and located as plat indicates.

#### DEED DESCRIPTION

Beginning at a point 73.94 chains South, West 16.19 chains, North 3° East 33.98 chains, North 54° West 1.50 chains, North 22° East along West side of County Road 143.00 feet, and South 72° East 60.00 feet to the East side of County Road from the Northeast Corner of Section 15, Township 15 South, Range 3 East, of the Salt Lake Base and Meridian; Thence South 72° East 41.00 feet to cement ditch, thence Northerly 500.00 feet, more or less, along West side of cement ditch, Thence North 75° West 121.00 feet to the East side of County Road, thence Southerly along East side of County Road 126.00 feet, more or less, to point of beginning. containing 1.28 acres more or less.

### SURVEY DESCRIPTION

Beginning at a point S 00°30′10″ E along the Section line 2468.29 feet and West 942.29 feet from the Northeast corner of Section 15, Township 15 South, Range 3 East, Salt Lake Base and Meridian, said point being on the East side of a County Road; thence S 72°00′00″ E 47.77 feet to the West side of a concrete ditch; thence along the West side of said ditch a total of 500.00 feet over the next six (6) courses, (1) Northeast along a 98.50 feet radius curve to the right 33.59 feet with a chord of N 76°30′54″ E 33.43 feet, (2) N 86°17′04″ E 40.87 feet, (3) along a 111.50 foot radius curve to the left 108.01 feet with a chord of N 58°31′58″ E 103.84 feet, (4) N 30°46′51″ E 47.78 feet, (5) N 31°35′57″ E 77.28 feet, (6) N 33°08′08″ E 192.57 feet; thence N 75°00′00″ W 225.36 feet to the East side of a County Raod; thence S 23°00′36″ W along East side of Said County road 408.87 feet to the point of beginning. 


