Executive Summary:

Located in the Southern Hills region located approximately 12 miles Southeast of Edgemont, SD on the Cheyenne River. The Hardy ranch encompasses 480 deeded acres with an additional 40 acres of Black Hills Forest fenced into the property. Having been held in the same family for over 60 years, the Hardy Ranch shows history of a time forgotten. A modest home site leaves little footprint when compared to the vast surrounding canyons, cedar breaks, and open valley grasslands.

Location:

The property is accessed off a well-maintained gravel county road, Rocky Ford Road. Approximately 12 miles east of the rural town of Edgemont, South Dakota.





Locale:

The surrounding area is in a world of its own, with the Custer National Park close by, as well as many other attractions such as Angostura Lake, Mount Rushmore, Jewel Cave National Monument, Crazy Horse Monument, and the Black Hills Wild Horse Sanctuary is just down the road. Spectacular views, wildlife sightings and live water features are in abundance, seemingly around every corner. Being located in the 'Southern Black Hills', the property experiences a mild climate with an average of 34 inches of snowfall annually and an annual rain fall of 17 inches in a mostly arid scene.

The small town of Edgemont is a short 15 minute drive, where your basic needs are met with k-12 schooling, grocery store, medical clinic, and eatery. Hot Springs is approximately 20 miles to the north where the county seat is, as well as more convenience accommodations.

Regional flight service is available within an hour half drive at Rapid City, SD. Rapid City is the second largest city in South Dakota and offers all types of shopping, fine and casual dining, medical facilities and industry.

Offered for your consideration at \$864,000 US Dollars, the Hardy Ranch is a oncein-a-lifetime type of property.


