BEGINNING at a 5/8 lnch Iron rod found in the north line of the called 52.34 acre tract for the most southerly corner of the above described 107.13 acre tract; THENCE SOUTH 52 DEGREES 36 MINUTES 00 SECONDS EAST, distance of 270.59 feet to a 5/8 inch iron rod found for the Northeast corner of the above described 52.34 acre tract; THENCE SOUTH 38 DEGREES 49 MINUTES 21 SECONDS WEST, distance of 1069.06 feet to a point in the northeast right-of-way of F.M. Highway No. 224;
