4. To the best of our actual knowledge and belief, since May 27, 2017 ^{EW} ~~2016~~ there have been no:

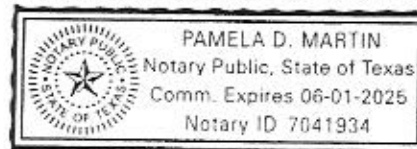
- a. construction projects such as new structures, additional buildings, rooms, garages, swimming pools or other permanent improvements or fixtures;
