JUDGMENT ON DECLARATION OF TAKING

This day came the Petitioner, United States of Amalea, by and through the United States Attorney for the Eastern District of Texas and by its Original Complaint moved the Court to enter a Judgment vesting such title and estates in the United States of Amarica as set out in the Declaration of Taking filed barein on the $\frac{6}{100}$ day of

September, 1955, in and to the property described in Schedule "A", attached to said Daclaration of Taking and hereto, and for an Order fixing the date when possession of such property is to be surrendered to the United States of America, and for the ascertainment and award of the just compensation to the owners and parties at interest, and the Court having considered said Complaint and Daclaration of Taking finds:

That each and all of the allegations in said Complaint and Declaration of Taking are true, and the United States of America is entitled to acquire property by eminent domain for the purposes set forth in said Complaint.

In said Complaint and Declaration of Taking a statement of authority under which said lands end easements were taken for said public uses is set forth.

The Petition for Condemation and the Daclaration of Taking were filed at the request of Wilber H. Brucker, Secretary of the Army of the United States of America, the person duly authorized by law to acquire
