



### **River Hills Ranches**

This beautiful little property offers many of the features that just can't be found inside city limit boundaries anymore. It is located just 10 minutes SE of Kempner in a quiet, gated rural subdivision on a high point, overlooking the Lampasas River Valley and close to 360-degree views of the surrounding area hills. The hard work has been done, as all unwanted underbrush and cedar have been removed, leaving only the best hardwood trees that add to the charm and aesthetic character of the property. There are Live Oaks, Post Oaks, Spanish Oaks and Elm trees dotting the landscape, and there is a great building site that overlooks the valley. There are common areas so that landowners can enjoy the Lampasas River and all that it has to offer. It is very hard to find so many positives in a property this size, but it delivers on expectations. There is an electrical line running along the boundary. A water well will be needed. An Ag Exemption is currently in place to ease the tax bite. The property is less than 10 minutes from Kempner, 20 minutes from Lampasas, 10 minutes from Copperas Cove, 20 minutes from Killeen, and about 1 hr. 15 minutes from Austin. The property is ready for you to establish your dream home and just kick back, enjoy the quiet, and view the world from your hilltop sanctuary.





















### Information About Brokerage Services

Texas law requires all real estate licensees to give the following information about brokerage services to prospective buyers, tenants, sellers and landlords.

### TYPES OF REAL ESTATE LICENSE HOLDERS:

- A BROKER is responsible for all brokerage activities, including acts performed by sales agents sponsored by the broker.
- A SALES AGENT must be sponsored by a broker and works with clients on behalf of the broker

## A BROKER'S MINIMUM DUTIES REQUIRED BY LAW (A client is the person or party that the broker represents):

- Put the interests of the client above all others, including the broker's own interests;
- Inform the client of any material information about the property or transaction received by the broker;
- Answer the client's questions and present any offer to or counter-offer from the client; and
- Treat all parties to a real estate transaction honestly and fairly.

## A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:

information disclosed to the agent or subagent by the buyer or buyer's agent. above and must inform the owner of any material information about the property or transaction known by the agent, including usually in a written listing to sell or property management agreement.
