



DESCRIPTION: This 40± acre timber tract is located in northeast Clark County, within the Yacolt Burn State Forest, between Silver Star and Larch Mountain. There is excellent access to the northeast portion of the property on a ridgetop logging road L1211. The property is part of the largest private inholding within the 90,000 acre Yacoh Burn State Forest, which extends into Skamania County.

The property is well-stocked with 22 year old Douglas-fir. It has moderate south-facing slopes. It will require a combination of ground-based and cable logging. Douglas-fir Site Class is III+.

It is projected that at age 40 years, the tract will have 20 MBF per acre. Some pre-commercial thinning could improve productivity.

The property is within a 25 minute drive of Vancouver, is 2.5 miles northeast of the Larch Corrections Center, and 3 miles southeast of Dole Valley.

There is a locked gate two miles northwest of the property at the intersection of L1200 and L1210 maintained by the Washington Department of Natural Resources. Seller, other private parties, and Washington Department of Natural Resources all have keys to the gate.

Acquisition of this 40± acre tract provides opportunity for ownership of a well-stocked timber tract at less than \$2,500 per acre and within proximity to log markets in Southwest Washington in Kalama, Longview, and east to mills in Bingen, Carson, and Hood River.


