Information About Brokerage Services

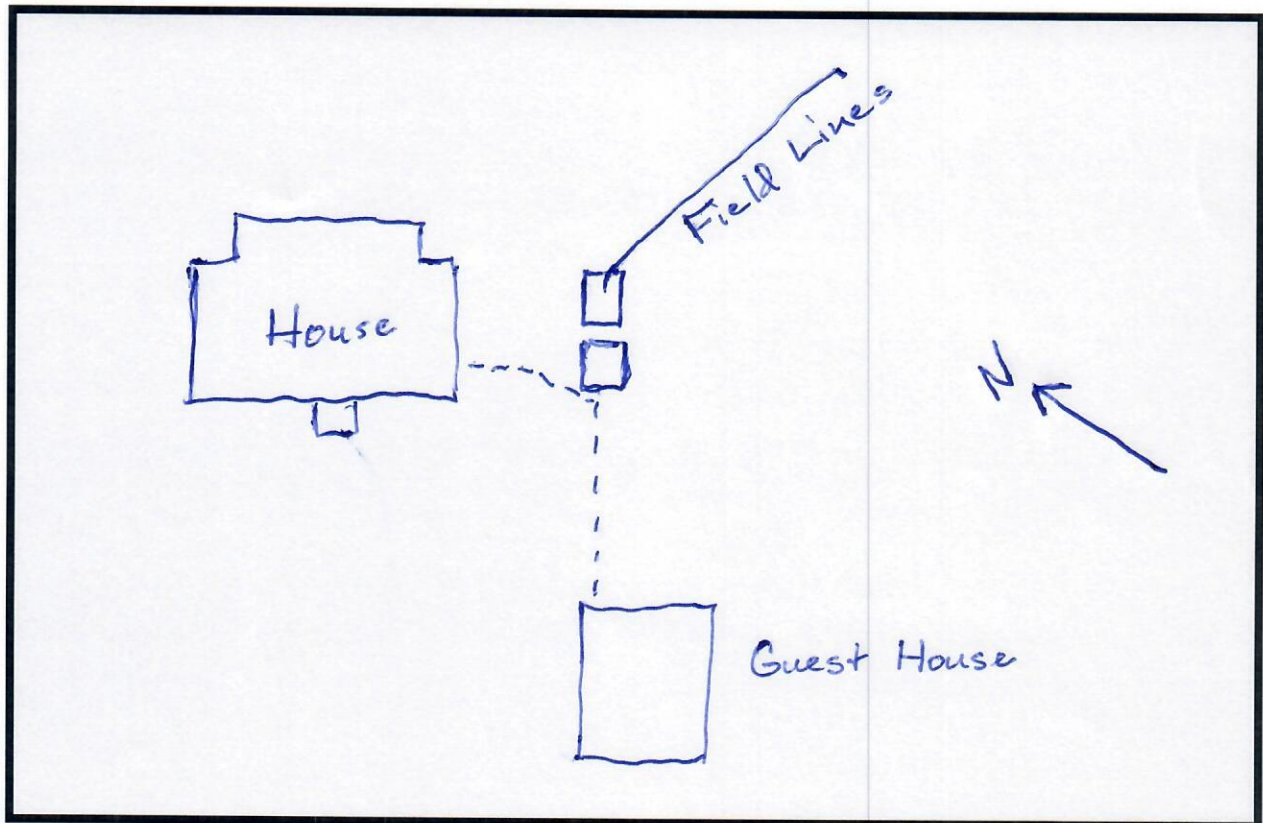
